4. The maximum amount the Judicial Council may pay Contractor under this Agreement (as amended) is **\$0** (the “Contract Amount”).

5. The parties agree to amend the Agreement as follows:
  - A. The purpose of this Amendment is to i) exercise the first option term.
  - B. Contractor will continue to provide the Judicial Council of California the Temporary Staffing Services.
  - C. The total amount the Judicial Council may pay contractor under this Agreement is unchanged and remains the same.
  - D. The Expiration Date of this Agreement is hereby changed from June 23, 2023 to **June 23, 2024**.

6. Except as provided in this Amendment, all terms and conditions of the original Agreement (as previously amended, if applicable) remain in full force and effect.
