 - C. The Agreement Number on Section 6.2, Invoicing and Payment of Appendix B, Payment Provisions is changed from 1036231 to **MA-SF201801**.
 - D. The JCC recipient for Notice of Changes under Appendix C, Section 9 is changed from Bernie Honey to **Brian Walsh**.
 - E. Appendix E, Authorized Users is hereby deleted and replaced with Appendix E, Authorized Users, Revision No. 1.
 - F. The Expiration date of the Agreement is changed from **June 30, 2019** to **September 30, 2019**.

6. Except as provided in this Amendment, all terms and conditions of the original Agreement (as previously amended, if applicable) remain in full force and effect.
