What's Happening Before

**Dependency Mediation?** 

#### **CPS Intervention**

- Referral assessed at hotline using an intervention assessment tool
- Allegations must meet a legal basis for intervention
- Hotline assesses information to determine level of intervention required
- Assigned as immediate or 10 day referral

#### **CPS Investigation**

- CPS worker assesses to determine if safety issues exist
- Safety issues can be mitigated with a safety plan
- Safety issues may require immediate removal

### **CPS Investigation**

- CPS worker assesses for risk
- Risk is future based
- High risk does not necessarily warrant removal
- Assessment of safety and risk determines level of CPS intervention

#### **CPS Assessment Tools**

- Structured Decision Making (SDM)- 54 counties in California
- Comprehensive Assessment Tool (CAT)- 4 counties in California
- Hotline response determination tool



#### **Child Abuse Central Index (CACI)**

- Database of child abuse investigation reports maintained by DOJ
- Performs searches for CPS, law enforcement, licensing agencies & employers
- Lists substantiated reports from all counties in California
- Build legal cases and stop repeat offenders



#### **CACI Due Process**

- Lists substantiated reports for abuse
- Physical, sexual, emotional & severe neglect
- No longer includes inconclusive findings
- Notification to offender required for substantiated report
- Offender has due process rights
- Grievance reviews for substantiated findings-Gomez hearings

#### **CPS Services**

- Legal requirement to provide pre-placement preventative services
- Services provided to family to mitigate safety/risk
- Differential response
- Voluntary family maintenance- non court intervention

#### **CPS Services**

- Unable to mitigate safety- removal is required
- Petition filed in court
- Voluntary family maintenance- court involvement
- Family reunification
- Permanent plan- legal guardianship, adoption

#### **Intervention Tools**

- Team decision making meetings (TDM)
- Family group conferencing (FGC)
- Family Team meetings (FTM)
- Dependency mediation
