Item 3

Overview of the January Budget Impact to Collaborative Courts

The January budget did not have a big impact on collaborative programs. The Byrne State Crisis Intervention Program is federal funding to implement a state gun crisis intervention and consists of several types of programs, including collaborative courts. First included in the 2023 annual agenda, this was to provide the committee with an opportunity to weigh in on how the funding will be allocated to courts. Now the federal government has given the money to the state; funding will be coming sometime this year. Staff will present on the funding once it becomes available. The anticipated date will be some time either in late spring or early summer.

One of the budget change proposals for the 2024-25 Budget, which would have given funding to the courts, if approved, was to have a line item to pay for IST evaluators. IST evaluators are those that are appointed by the courts at competency to stand trial proceedings. This has been a big challenge for courts with the increase for competency evaluations, without any dedicated funding. This budget change proposal is not moving forward.
