State Task Force to Hold Public Hearings On Probate Conservatorships in Trial Courts

Hearings Scheduled in Los Angeles, San Francisco; Goal is to Improve Oversight of Cases in State Courts

San Francisco—The Judicial Council's new Probate Conservatorship Task Force will hold two public hearings later this month as it begins an in-depth study on how to improve the management and oversight of conservatorships in the California trial courts.

- The first hearing will be held from 10:30 a.m. to 3:30 p.m. on Friday, March 17, in the Ronald Reagan State Building, Auditorium, First Floor, 300 South Spring Street, Los Angeles.
- The second hearing will be held from 10:30 a.m. to 3:30 p.m. on Friday, March 24, in the Hiram Johnson State Office Building, Auditorium, Lower Level, 455 Golden Gate Avenue, San Francisco.

Appointed by Chief Justice Ronald M. George, the task force is charged with making recommendations for reforms and improvements in the overall administration of probate conservatorships. The task force is convening these public hearings to seek broad input from stakeholders with knowledge and expertise about the conservatorship system. The 16-member task force is chaired by Administrative Presiding Justice Roger W. Boren of the Court of Appeal, Second Appellate District (Los Angeles).

At each public hearing, the task force will hear testimony from the public and a wide range of speakers including judges, court investigators, public and private conservators, attorneys and legal advocacy groups, and law enforcement representatives. Topics at the hearings will include:

- A fresh look at temporary conservatorships.
- How to increase court oversight and accountability in permanent conservatorships.
- Improving collaboration with key justice system partners.
- Innovative approaches to handling conservatorship cases.

The agendas for both hearings, which are open to press and public, are attached.

The Judicial Council is the policymaking body of the California courts, the largest court system in the nation. Under the leadership of the Chief Justice and in accordance with the California Constitution, the council is responsible for ensuring the consistent, independent, impartial, and accessible administration of justice. The Administrative Office of the Courts carries out the official actions of the council and promotes leadership and excellence in court administration.
