### PROPOSALS FOR JUDICIAL COUNCIL-SPONSORED LEGISLATION

## a) Surplus of San Pedro Courthouse (Action Required)

The proposed sponsored legislation would authorize the disposition of the San Pedro Courthouse once it has been declared as surplus property by the Judicial Council.

# b) Amendments to Penal Code sections 1203.2(a),1170(h)(5)(B) and 3456 (b) (Action Required)

The Criminal Law Advisory Committee, following the decision in *People v. Leiva* (2013) 56 Cal 4th 498, proposes statutory amendments to Penal Code sections 1203.2(a), 1170(h)(5)(B) and 3456 (b) to address the jurisdiction of courts to adjudicate alleged violations of supervision that occur after the original supervision term has expired, but during a period when supervision had been summarily revoked. The amendments would clarify the legislature's intent that the time during revocation, summary or otherwise, shall not be credited toward any period of supervision. This proposal was developed at the request of judges to ensure that court jurisdiction over defendants under any form of court-ordered supervision is preserved and to authorize courts to reinstate and extend supervision following a violation, whether or not the violation occurred during the original term of supervision.

### c) Probate: Statements of Decision in Probate Proceedings (Action Required)

The Probate and Mental Health Advisory Committee is proposing legislation that would clarify when statements of decision after court trials are required, are within the discretion of the court, or are not required, and to provide a procedure for issuing them, in proceedings under the Probate Code.

## d) Timing of Electronic Service (Action Required)

The Civil and Small Claims Advisory Committee is proposing legislation to, which addresses the time of service of supporting and opposing papers for specified motions. The Civil and Small Claims Advisory Committee recommends amending section 1005 to (1) clarify that service of motion papers may be made electronically, and (2) provide that if a document is served electronically, the notice period before a hearing is extended two court days.
