Summary of Cases Accepted During the Week of July 23, 2007

[This news release is issued to inform the public and the press of cases that the Supreme Court has accepted and of their general subject matter. The statement of the issue or issues in each case set out below does not necessarily reflect the view of the court, or define the specific issues that will be addressed by the court.]

#07-317 People v. Kim, S153183. (H029324; 150 Cal.App.4th 1158; Monterey County Superior Court; SM970463.) Petition for review after the Court of Appeal reversed orders in a criminal proceeding. This case includes the following issues: (1) Is a person who petitions for a writ of habeas corpus "restrained of his liberty" within the meaning of Penal Code section 1473, subdivision (a), when he is in the custody of federal immigration officials solely because of a California conviction on which the sentence has fully expired? (2) Is the writ of error coram nobis available to challenge a California conviction on which the sentence has fully expired if the conviction is presently the basis of federal immigration proceedings and the petitioner alleges that trial counsel failed to properly advise him as to the immigration consequences of the conviction and that he did not in fact know what those consequences would be? (3) Did the trial court have the power to grant petitioner's non-statutory motion to vacate judgment for ineffective assistance of counsel in failing to properly advise him of the immigration consequences of the conviction?
