

## **I. Disposition Plan**

The Administrative Office of the Courts (AOC) submits this “Judicial Branch Disposition Plan for Transferred Court Facilities” (the plan) on behalf of the judicial branch, in accordance with the legislative mandate on reporting requirements as stated under Judicial Branch, Capital-Outlay Item 0250-301-3037 of the *Supplemental Report of the 2007 Budget Act: 2007–2008 Fiscal Year*, published by the Legislative Analyst’s Office in August 2007. The plan encompasses the reporting period of July 1, 2004, through June 30, 2007, and addresses the disposition of all trial court facilities that have been transferred to the state or for which individual counties otherwise have been relieved of responsibility, pursuant to the Trial Court Facilities Act of 2002 (Sen. Bill 1732 [Escutia] Stats. 2002, ch. 1082 and subsequent modifying language).

The plan includes a list identifying a total of 119 trial court facilities that have been addressed under transfer agreements, indicating each by county, the building name, transfer type, and planned disposition of the facility. The majority of these facilities continue to operate as court facilities and are not expected to be discontinued. A smaller number of facilities were included among those inventoried in the *2001 Final Report of the Task Force on Court Facilities* but were either not occupied by the court at the time of transfer negotiations or were replaced or will be replaced by county-funded or state-funded new construction projects that are presently underway. Because of the overcrowding of existing court facilities and the increasing demand for space for court operations and public services, existing court facilities will not be vacated until the judicial branch’s Trial Court Capital Outlay Plan is fully implemented, notwithstanding the poor physical condition of many of the facilities.

## **II. Background on Court Facilities Transfers**

The Lockyer-Isenberg Trial Court Funding Act of 1997 shifted responsibility for funding trial court operations from the counties to the state and established the Task Force on Court Facilities (Task Force) to identify facility needs and possible funding alternatives. It was the overarching recommendation of the Task Force that the responsibility for trial court facilities funding and operation be shifted from the counties to the state. The Task Force recommended that the judicial branch, which is wholly responsible for all court functions, also should be responsible for the facilities in which it operates.

In 2002, the Trial Court Facilities Act was enacted. The act provides for the shift of responsibility for trial court facilities—including operations, maintenance, facility modifications, and capital outlay projects—from county to state governance, under the direction of the Judicial Council of California. The act was the final step in restructuring the courts into an integrated judicial branch and the primary legislation by which trial court facilities have transferred to the state.

The act provided that negotiations of transfer agreements were to begin on July 1, 2003, and that the transfers could begin on July 1, 2004. From July 1, 2004, to June 30, 2007, (i.e., the final date for transfers under the original legislation), 119 trial court facilities have been addressed by executed transfer agreements.

### **III. Plan Contents**

The plan includes a list identifying each transferred court facility alphabetically by county, which is listed under the first column heading. The other columns describe the transferred facility by name, type of transfer, and planned disposition. The transfer types fall into one of five categories:

- **Transfer of Responsibility:** Defined as transfer of responsibility for specific space occupied exclusively by the court within a facility for which the state has responsibility for the continued operations and maintenance of that space and a proportional share of any common areas and systems. The Transfer of Responsibility may or may not include a change in ownership of the property (Transfer of Title) on which the facility is located.
- **Transfer of Title:** Defined as a change in the record ownership of the entire facility within which the court operates from county to state ownership.
- **Special Transfer by MOU:** Defined as a transfer under terms specified in a Memorandum of Understanding (MOU) agreement between the AOC, the court, and the county government that specifies conditions for the continued, perpetual use of the facility by the court for its operations, without cost to the state or court, and relieves the county of obligations to provide future space to meet the needs of the court. The MOU transfer typically is used for historic courthouses and may also be used for incidental spaces made available to the court such as hearing rooms in psychiatric care hospitals.
- **Consolidated:** Defined as applicable to a facility that no longer is used for court operations, as those operations have been combined with operations at other court facility location(s). Consolidation may have occurred after the Task Force's inventory of court facilities and before transfer discussions or as part of an agreement related to the construction of a new courthouse to replace the former court facility.
- **Deferred Transfer:** Defined as applicable to a facility where the Transfer of Responsibility has been completed and a Transfer of Title will occur in the future, on the retirement of any outstanding county financing debt or encumbrances.

### **IV. Disposition Reporting Process**

The plan has been prepared in accordance with the reporting requirements as stated under Judicial Branch, Capital-Outlay Item 0250-301-3037 of the *Supplemental Report of the 2007 Budget Act: 2007–2008 Fiscal Year*, published by the Legislative Analyst's Office in August 2007. The plan is submitted to the chairs of the fiscal committees of both houses of the Legislature and the chair of the Joint Legislative Budget Committee. This is the first plan submitted for review; the AOC will hereafter report on the disposition of additional transferred facilities on a semiannual basis, in accordance with stated reporting requirements.
