3. At the expiration of the period of probation, if DONALD CHARLES SCHWARTZ has complied with all conditions of probation, the two-year period of stayed suspension will be satisfied and that suspension will be terminated.

DONALD CHARLES SCHWARTZ must take and pass the Multistate Professional Responsibility Examination within one year after the effective date of this order and provide satisfactory proof of such passage to the State Bar's Office of Probation within the same period. Failure to do so may result in suspension. (Cal. Rules of Court, rule 9.10(b).)

DONALD CHARLES SCHWARTZ must also comply with California Rules of Court, rule 9.20, and perform the acts specified in parts (a) and (c) of that rule within 30 and 40 calendar days, respectively, after the effective date of this order. Failure to do so may result in disbarment or suspension.

Costs are awarded to the State Bar in accordance with Business and Professions Code section 6086.10 and are enforceable both as provided in Business and Professions Code section 6140.7 and as a money judgment.

Resignation declined

This court, having considered the request, declines to accept the voluntary resignation with charges pending of ROGER JAY ROSEN, State Bar Number 48573, as a member of the State Bar of California. (Cal. Rules of Court, rule 9.21(d).) ROGER JAY ROSEN remains on inactive status. (Cal. Rules of Court, rule 9.21(a).) He may move the State Bar Court to be restored to active status, at which time the Office of the Chief Trial Counsel may demonstrate any basis for his continued ineligibility to practice law. The State Bar Court will expedite the resolution of any request by ROGER JAY ROSEN to be restored to active status. Any return to active status will be conditioned on ROGER JAY ROSEN's payment of any dues, penalty payments, and restitution owed by him. The underlying disciplinary matter should proceed promptly.
