



**JUDICIAL COUNCIL OF CALIFORNIA
STANDARD AMENDMENT COVERSHEET**

MASTER AGREEMENT NUMBER MA-202101	AMENDMENT NUMBER 3

1. All capitalized terms not defined in this amendment (the "Amendment") have the meanings given to them in the Master Agreement referenced above ("Agreement"). As set forth in the Agreement, the term "Contractor" refers to **GovernmentJobs.com, Inc. dba Neogov** and the term "Judicial Council" or "State" refers to the **Judicial Council of California**.
2. This Amendment becomes effective on **July 1, 2024**.
3. The parties agree to amend the Master Agreement as follows:
 - a) The purpose of this Amendment is to exercise the First Option Term in accordance with Exhibit C, Section 1 under the Term section of the Agreement; thereby extending the Term of the Agreement for one (1) year.
 - b) The expiration date is hereby changed from July 1, 2024, to June 30, 2025.
 - c) The fees set forth in Exhibit B- Pricing and Payment shall be subject to CPI-based adjustments not to exceed the percentage change in the 12-month average. Fees may not be increased more than once in any 12-month period.
 - d) Exhibit B- Pricing and Payment of the Agreement is hereby deleted and replaced in entirety with Exhibit B- Pricing and Payment- Revision 1 attached hereto and incorporated herein.
4. Except as provided in this Amendment, all terms and conditions of the Agreement, as previously amended shall remain in full force and effect.
