## **1.0 BACKGROUND INFORMATION**

- 1.1 <u>Judicial Council of California</u>. The Judicial Council of California, chaired by the Chief Justice of California, is the chief policy making agency of the California judicial system. The California Constitution directs the council to improve the administration of justice by surveying judicial business, recommending improvements to the courts, and making recommendations annually to the Governor and the Legislature. The council also adopts rules for court administration, practice, and procedure, and performs other functions prescribed by law. The Judicial Council of California is the staff agency for the council and assists both the council and its chair in performing their duties.
- 1.2 Meeting for advisory body and internal committee chairs, vice-chairs and lead staff.

## 2.0 DESCRIPTION OF SERVICES AND DELIVERABLES

- 2.1 <u>Program</u>. The Judicial Council of California seeks the hotel for the following program:
  - Title: Judicial Council Advisory Body Leadership Meeting
  - Dates: October 20, 2024
  - Description: Furnish sleeping rooms for the program
  - Location: San Francisco (Union Square, Yerba Buena Garden, Nob Hill and South Polk Street only) *no preference order*
  - Payment: U.S. Bank National Association Travel Payment Services Card (TPSC)
- 2.2 <u>Maximum Rates and Fees</u>. Preference will be given for costs proposed within the maximum rates and fees established by the Judicial Council of California, as set forth below. *However please submit hotel's best available rate if the county maximum listed below cannot be accommodated.*

Judicial Council of California's maximum sleeping room unit rate: \$185.00

2.3 The Judicial Council of California, Conference & Registration Services does not retain the services of third party or outsourced representation. All quoted rates are to be net, not commissionable.

## 4.0 EVALUATION OF PROPOSALS

At the time proposals are opened, each proposal will be checked for the presence or absence of the required proposal contents.

The Judicial Council of California will evaluate the proposals on a 100-point scale using the criteria set forth in the table below. Award, if made, will be to the highest scored proposal.

An "exception" includes any addition, deletion, or other modification. If exceptions are identified, the Proposer must also submit a red-lined version of the Terms and Conditions that clearly identifies the benefit to the Judicial Council from the proposed exception and provides a written explanation or rationale for each proposed exception. <b>Note: A material exception, as determined by the Judicial Council in its absolute and sole discretion, to any of the Terms and Conditions will render a proposal non- responsive.</b>
Attachment 4: Darfur Contracting Act Certification	Proposer must complete the Darfur Contracting Act Certification and submit the completed certification with its proposal.

Attachment 6: Conflict of Interest Certification Form	Proposer must complete Conflict of Interest Certification and submit the completed certification with its proposal

#### 6.0 SUBMISSIONS OF PROPOSALS

- 6.1 Proposals should provide straightforward, concise information that satisfies the requirements of the "Proposal Contents" section below.
- 6.2 The Proposer must submit its proposal by e-mailing it to the following JCC mailbox: <u>ConferenceRFPs@jud.ca.gov</u> Proposers must indicate the RFP title and RFP number (CRS AK 435, JC Advisory Body Leadership Meeting) in the subject line of the e-mail and on each attachment submitted.
- 6.3 **Proposals must be delivered by the date and time listed on the coversheet of this RFP.** The only acceptable proof of delivery for submittals made by e-mail will be the automated receipt (with a date and time receipt) generated by the JCC mailbox upon the successful receipt of the proposer's emailed proposal. Submission

acceptance will be based on the date and time the e-mails are received by the Judicial Council.

- 6.4 Late proposals will <u>not</u> be accepted. Proposals received after the deadline will be rejected without review.
- 6.5 Only written proposals via e-mail will be accepted. Proposals may not be transmitted by fax. Incomplete submittals may be rejected without review.

## 7.0 PROPOSAL & COST CONTENTS

- 7.1 <u>Technical & Cost Proposal (Attachment 5)</u>. The following information must be included in the technical & cost proposal. A proposal lacking any of the following information may be deemed non-responsive.
- a. Legal name and address of firm (Proposer), the Contact's name, title, telephone numbers and E-mail address, federal tax identification number, web site, hotel check-in/out time, and guest room reservation cancellation policy. Note that if Proposer is a sole proprietor using his or her social security number, the social security number will be required before finalizing a contract.
- b. Propose room block date.
- c. Propose sleeping room unit rate(s).
- d. Answer ADA compliance question.
- e. Propose the cut-off date for reservations.
- i. Propose the sleeping room rate(s) for tax and/or surcharges.
- g. Propose parking passes, complimentary passes and normal parking rate(s), inclusive of any service charges, gratuity, and/or sales tax.
- h. Propose Internet fees for meeting space and individual guest rooms.
- i. Acceptance of additional program needs and concessions.
- j. Provide the signature of the proposer.

**NOTE:** It is unlawful for any person engaged in business within this state to sell or use any article or product as a "loss leader" as defined in Section 17030 of the Business and Professions Code.

7.2 Acceptance of the Terms and Conditions.

- a. On Attachment 3, the Proposer must either indicate acceptance of the Terms and Conditions or clearly identify exceptions to the Terms and Conditions in the Standard Agreement (Attachment 2).
- b. If exceptions are identified, the Proposer must also submit a red-lined version of the Terms and Conditions that clearly tracks proposed changes, and a written explanation or rationale for each exception and/or proposed change.
- c. Note: A material exception, as determined by the Judicial Council in its absolute and sole discretion, to any of the Terms and Conditions will render a proposal non-responsive.
- 7.3 Certifications, Attachments, and other requirements.
- a. Proposer must include the following certification in its proposal:

Using Attachment 6, Proposer has no interest that would constitute a conflict of interest under California Public Contract Code sections 10365.5, 10410 or 10411; Government Code sections 1090 et seq. or 87100 et seq.; or rule 10.103 or rule 10.104 of the California Rules of Court, which restrict employees and former employees from contracting with judicial branch entities.

- b. If Proposer has had business activities or other operations outside of the United States within the previous three years, Proposer must complete the Darfur Contracting Act Certification attached as Attachment 4 and submit the completed certification with its proposal.
- c. If Proposer is a corporation, proof that Proposer is in good standing and qualified to conduct business in California.
- 7.4 Submission of Proposals
  - a. The Proposer should include the following attachments:
    - Attachment 2 Judicial Council of California Standard Terms and Conditions – only if there are exceptions/modifications as indicated on Attachment 3.
    - Attachment 3 Proposer's Acceptance of Terms and Conditions
    - Attachment 4 Darfur Contracting Act Certification
    - Attachment 5 Submission form for Technical & Cost Proposal
    - Attachment 6 Conflict of Interest Certification Form

#### 8.0 OFFER PERIOD

A Proposer's proposal is an irrevocable offer for sixty (60) days following the proposal due date. In the event a final contract has not been awarded within this sixty (60) day period, the Judicial Council of California reserves the right to negotiate extensions to this period.

#### 9.0 INTERVIEWS

The Judicial Council of California may conduct interviews with Proposers to clarify aspects set forth in their proposals. If conducted, interviews will likely be conducted by phone or during site visits. The Judicial Council of California will not reimburse Proposers for any costs incurred pertaining to an interview, including travel expenses. The Judicial Council of California will notify eligible Proposers regarding interview arrangements.

#### 10.0 RIGHTS

The Judicial Council of California reserves the right to reject any and all proposals, in whole or in part, as well as the right to issue similar RFPs in the future. This RFP is in no way an agreement, obligation, or contract and in no way is the Judicial Council of California or the State of California responsible for the cost of preparing a proposal. One copy of each proposal will be retained by the Judicial Council of California for official files and will become a public record.

## 11.0 CONFIDENTIAL OR PROPRIETARY INFORMATION

California judicial branch entities are subject to rule 10.500 of the California Rule of Court (see <u>www.courtinfo.ca.gov/cms/rules/index.cfm?title=ten&linkid=rule10\_500</u>), which governs public access to judicial administrative records.

If information submitted in a proposal contains material noted or marked as confidential and/or proprietary that, in the Judicial Council of California's sole opinion, meets the disclosure exemption requirements of Rule 10.500, then that information will not be disclosed upon a request for access to such records. If the Judicial Council of California finds or reasonably believes that the material so marked is **not** exempt from disclosure, the Judicial Council of California will disclose the information regardless of the marking or notation seeking confidential treatment.

## 12.0 DISABLED VETERAN BUSINESS ENTERPRISE PARTICIPATION GOALS

The Judicial Council of California has waived the inclusion of DVBE participation in this solicitation.

#### 13.0 PROTESTS

Any protests will be handled in accordance with Chapter 7 of the Judicial Branch Contract Manual (see <u>www.courts.ca.gov/documents/jbcl-manual.pdf</u>). Failure of a Proposer to comply with the protest procedures set forth in that chapter will render a protest inadequate and non-responsive, and will result in rejection of the protest. The deadline for the Judicial Council of California to receive a solicitation specifications protest is the due date and time for submittal of proposals.
