Court Grants Request

4. The court makes the findings stated below:
 - a. Notice of the date, time, and location of the hearing was given as required by law.
 - b. Notice of the request was provided to the nonminor and the attorney for the nonminor.
 - c. The placing agency made reasonable efforts to meet the nonminor's needs prior to a foster care placement.
 - d. It is in the best interest of the nonminor to reenter foster care as a nonminor dependent.
5. The court makes the order stated below:
 - a. The court grants the request to dismiss jurisdiction under Welfare and Institutions Code section 300 or section 450 and to assume general jurisdiction over the nonminor under section 303, and then resume jurisdiction over the nonminor under section 300 or section 450 to establish the nonminor's eligibility for federal financial participation in the cost of the nonminor's care.
 - b. Placement and care are vested with the placing agency.
 - c. The placing agency must establish a new agreement for extended foster care with the nonminor and ensure no break in service or support.
 - d. A transitional independent living case plan has not previously been established. The placing agency must develop with the nonminor a new plan and file it with the court within 60 days.
 - e. A nonminor dependent review hearing under Welfare and Institutions Code section 366.31 and rule 5.903 of the California Rules of Court is set for (date): _____
