1. All capitalized terms not defined in this amendment (the "Amendment") have the meanings given to them in the Master Agreement referenced above ("Agreement"). As set forth in the Agreement, the term "Contractor" refers to **Language Select, LLC dba United Language Group, LLC** and the term "Judicial Council" or "State" refers to the **Judicial Council of California**.
2. This Amendment No. 4 to Agreement No. MA-201308 becomes effective on: **May 1, 2018**.
3. The parties agree to amend the Master Agreement as follows:
  - a) The expiration date of the Master Agreement is hereby changed from June 30, 2018 to June 30, 2020.
  - b) Exhibit C, Payment Provisions is hereby revised with the following:

The new prices/fees for (Non-Certified) Statewide Limited Telephonic Interpreter Services is a flat rate of \$0.57 per minute for all languages.

The new prices/fees for (Certified) Statewide Limited Telephonic Interpreter Services for all languages shall be discounted based on a tiered pricing below:

0 – 5,000 mins per month pricing as is

5,000 – 10,000 mins per month 5% reduction

10,000 – 20,000 mins per month 8% reduction

20,000+ mins per month 15% reduction



The prices above becomes effective from May 1, 2018 to June 30, 2020.
  - c) Revise Section 22 (b) and (d), Requests; Communication; Notices.
