1. All capitalized terms not defined in this amendment (the "Amendment") have the meanings given to them in the Agreement referenced above. As set forth in the Agreement, (the "Master Agreement"), the term "Contractor" refers to **Dunbar Armored, Inc.**, and the term "**Judicial Council**", "**AOC**", or "**State**" refers to the **Judicial Council of California**.



2. The title of this Master Agreement is: Armored Car Services. The parties agree that the Contractor will furnish to the 58 Superior Courts of California, the Appellate Courts, the Supreme Court of California, and the Judicial Council (individually referred to as a member of the "Purchasing Group" or "Customer"), services and materials as required in this Master Agreement.
The title listed above is for administrative reference only and does not define, limit, or construe the scope or extent of the Agreement

3. This Amendment becomes effective on **July 1, 2016** and expires **August 31, 2016**.

4. WHEREAS, The Judicial Council issued RFP Number BAP-2016-01-PC for armored car pickup services for the Superior Courts of California on March 11, 2016; and
WHEREAS, Contractor submitted a proposal to provide the requested armored car pickup services; and
WHEREAS, the Judicial Council issued a Letter of Intent on May 10, 2016 to award a master agreement for the requested services to Contractor; and
WHEREAS, the parties agree to extend the term of the current Master Agreement for an additional two months to allow sufficient time to complete the contract award;
NOW THEREFORE, the parties agree to enter into this Amendment No. 004.

5. The parties agree to amend the Master Agreement as follows:
 - a) The purpose of this Amendment is to extend the term and pricing of the Agreement for an additional two months.
 - b) Contractor shall continue to provide Armored Car Services, including furnishing to the 58 Superior Courts of California, the Appellate Courts, the Supreme court of California, and the Judicial Council (individually referred to as a member of the "Purchasing Group" or "Customer"), services and materials as required in Master Agreement No. MA 301110.
 - c) The expiration date of the Master Agreement is hereby changed from **June 30, 2016** to **August 31, 2016**.

5. Except as provided in this Amendment, all terms and conditions of the original Agreement remain in full force and effect.
