1. All capitalized terms not defined in this amendment (the "Amendment") have the meanings given to them in the Agreement referenced above. As set forth in the Agreement, the term "Contractor" refers to **HUMANSKALE CORPORATION**, and the term "Judicial Council" refers to the **JUDICIAL COUNCIL OF CALIFORNIA**.

2. Title of the Agreement: **Ergonomic Assessment Services and Equipment Recommendations**

3. This Amendment becomes effective on **July 1, 2018**

4. The parties agree to amend the Agreement as follows:
 - A. The purpose of this Amendment is to exercise the First Option Term in accordance with Exhibit B, Special Provisions, Options to Renew; thereby extending the Term of the Agreement for one (1) year.
 - B. Contractor will continue to perform Ergonomic Assessment Services and Equipment Recommendations throughout the term of the Master Agreement, in accordance with Exhibit D, Work to be Performed.
 - C. The expiration date of the Agreement is hereby changed from June 30, 2018 to **June 30, 2019**.

5. Except as provided in this Amendment, all terms and conditions of the original Agreement (as previously amended, if applicable) remain in full force and effect.


