Quarter 4

1. Shasta County Superior Court - Collections Division provides our court with comprehensive collection services. While our case management system is able to separate all collections payments from forthwith payments, it is not able to differentiate between payments made directly to Shasta, Franchise Tax Board, MSB or any other third party vendor that Shasta may use to collect on Colusa's behalf. Thus, this section is being used for reporting purposes.

2. An adjustment to the first quarter figures was made within the second quarter to all reported cells (except for civil assessments). Figures reported for the first quarter were overstated by the amount of the Court's costs recovered through its enhanced collections program.
