Report Back from Working Groups

Each of the working groups presented generally on their morning discussions. Working groups include: Representation, Research and Best Practices, Process Improvements, and Improving the Status of, and Respect for, Family Law Litigants, and Family Law.

Members discussed general crossover and overlapping issues between working groups and how to address such issues. Staff will distribute documents with each working group's narrowed focus via the Moodle web site.

Summary of Cochairs Meeting

The September 15 meeting was summarized, where cochairs met to discuss working groups as well as review the guiding principles that could be used to help guide the final recommendations of the task force. Members should provide comments so that the principles may be finalized.

The task force also reviewed an outreach form.

Focus Groups

The task force received a summary on the status of the upcoming focus groups: The AOC has contracted with CERES policy research who will be conducting 18 focus groups that will include meetings with represented and self-represented litigants, 5 English speaking groups, and 1-2 Spanish speaking groups. The research staff has completed a focus group fact sheet that contains additional information.

Bar Survey

The idea of the California State Bar survey is to gather information to build on the focus groups and key informant interviews. The survey would probe into specific areas that the other methods would not necessarily address. The final survey will be put on a Survey Monkey-type tool that would be sent as a link and be completely confidential. It will be publicized through articles in the state bar, family law newsletters, email outreach, and hardcopies only to those that cannot complete online.

Members provided input on individual survey questions.
