1. All capitalized terms not defined in this addendum (the "Addendum") have the meanings given to them in the Master Agreement referenced above ("Agreement"). As set forth in the Agreement, the term "Contractor" refers to **Avantpage, Inc.** and the term "**Judicial Council**" or "**State**" refers to the **Judicial Council of California**.

2. This Addendum becomes effective on **October 23, 2021**.

3. The parties agree to amend the Master Agreement as follows:
  - a) Judicial Council hereby exercises its first option to extend the term of the agreement from October 23, 2021 through October 22, 2022.
  - b) Add an item "I" under Services and Deliverables (2. Services and Deliverables. 2.1 Description of Services) and move the current item I to J and insert this item at "I":

Contractor will apply accessibility features to translated documents, Judicial Council forms, and web content, including but not limited to tab order, tags, translated image alternative text, translated customized screen reader text, and screen reading order to allow access to translated content through the use of screen readers. Unless otherwise directed by the JBE, contractor agrees to adhere to the Web Content Accessibility Guidelines (WCAG), version 2.1 at the AA conformance level (guidelines available at <https://www.w3.org/WAI/standards-guidelines/wcag/>). Before submitting final translations, Contractor will validate accessibility using Adobe Acrobat Pro DC and provide a report for each batch of translated materials (not including web content) that confirms conformance with the above standards at the time of submission.

4. Except as provided in this Amendment, all terms and conditions of the Agreement, shall remain in full force and effect.
