Re: Report on Allocation of Funding in 2019–20 for Support of New Judgeships Authorized in 2007–08

Dear Ms. Jenkins, Ms. Contreras, and Ms. Parker:

Pursuant to the Budget Act of 2007 (Stats. 2007, ch. 171, 172) the Judicial Council is required to report annually to the Legislature on the allocation of funding for support of new judgeships authorized in 2007–08 until all judgeships are appointed and new staff hired. The Judicial Council is submitting the annual *Report on Allocation of Funding in 2019–20 for Support of New Judgeships Authorized in 2007–08*.

For 2019–20, a total of \$28.487 million was allocated in support of new judgeships: \$28.035 million for operations costs from the Trial Court Trust Fund for 54 courts, and \$452,000 for facilities costs from the Court Facilities Trust Fund for three courts.

The table below displays the 2019–20 allocation of the ongoing funding for operations and facilities costs by individual court.
