Re: Report on Purchase or Lease of Electronic Recording Equipment by Superior Courts (July 1–December 31, 2013)

Dear Ms. Boyer-Vine, Mr. Schmidt, and Mr. Wilson:

The Judicial Council respectfully submits this report, as required by Government Code section 69958, to provide information to the Legislature about superior court purchases and leases of electronic recording equipment during the period of July 1, 2013, through December 31, 2013. As required by statute, for each purchase or lease of equipment, the report specifies the name of the court, the types of proceedings for which the equipment will be used, the cost of the equipment, and the types of equipment purchased or leased.

Government Code section 69957 requires the courts to obtain advance approval from the Judicial Council before purchasing or leasing any electronic recording technology or equipment. Approval for purchase or lease of the equipment is subject to the equipment's being used only in the manner and for the purposes authorized under that section. All 58 superior courts were surveyed about their purchase or lease of the equipment to ensure that all purchases were made with the required authorization. During the July 1 through December 31, 2013 period, three

courts made purchases of electronic equipment or related items for use in court proceedings. Of these three courts, two submitted Request to Purchase forms between July 1 and December 31, 2013, received authorization for their purchases, and subsequently made purchases. The third court received permission to purchase multiple sets of equipment in the period July 1 through December 31, 2012. Most of the approved equipment was purchased during previous periods, but the final equipment was purchased in the current period. Finally, two courts received approval to purchase during the July 1 through December 31, 2013 period, but did not purchase the equipment during the period. Information about the three purchase transactions follows.

The Superior Court of Merced County spent \$4,908 to purchase one FTR Gold with DMX-8 audio mixer. The purchase was not an upgrade or replacement of existing equipment. The device will be used to make an official record in small claims, infraction, misdemeanor, and limited civil cases.

The Superior Court of Orange County spent \$30,587 to purchase 12 Presonus FP 109 mixers and 12 Court Audio, Audio Trax SW981-8, 8-channel recording software. The purchase was not an upgrade or replacement of existing equipment. The devices will be used to make an official record in infraction, misdemeanor, and limited civil cases.

The Superior Court of Riverside County spent \$13,056 to purchase three FTR Touch 4 channel recording systems and three FTR USB DX 8-channel mixers. The purchase was not an upgrade or replacement of existing equipment. The devices will be used to make an official record in small claims, infraction, and infraction appeal cases.

The total amount spent by these three superior courts on the purchase of electronic recording equipment during the reporting period was \$48,551.
