Re: Notification of Vacancies and Allocation of Conversion of Subordinate Judicial Officer Positions as Required Under Government Code Section 69615

Dear Senator Perata, Senator Corbett, Speaker Núñez, and Assembly Member Jones:

Assembly Bill 159 (Stats. 2007, ch. 722), authorized the Judicial Council to convert 162 subordinate judicial officer positions, upon vacancy, to judgeships at a rate of up to 16 per fiscal year. In fiscal year 2007–2008, to date, 12 positions have been converted to judgeships in eligible courts. Beginning in fiscal year 2008–2009, AB 159 requires the Judicial Council to file

notice of the vacancies in subordinate judicial officer (SJO) positions that the council would be seeking to convert in that year, as well as the allocation of conversions among the 25 courts eligible for conversion of SJO positions.

In December 2007, the Judicial Council approved the following approach for allocating the 16 conversions among the courts eligible for conversion of vacant subordinate judicial officer positions to judgeships:

The percentage of total SJO conversions for each grouping corresponds roughly to the proposed allocation identified for each group beginning in FY 2008–2009. For example, group 3 is entitled to 24 percent of the total 162 conversions and 25 percent of the 16 conversions in each fiscal year. For courts in groups 3 and 4, the conversions will be allocated in the order that courts notify the Administrative Office of the Courts (AOC) of a confirmed vacancy before the end of the fiscal year. If the total number of vacancies reported to the AOC by any court or group of courts does not reach the number of positions set aside for that court or group of courts by April 1, the remaining positions set aside for conversion will be distributed to any other eligible court on a first-come, first-served basis.

The methodology for allocating the 16 annual conversions among the 25 eligible courts balances the long-term goal of achieving a more appropriate balance between judgeship and SJO positions in the superior courts with the short-term, immediate needs of the courts to handle their workload. The Judicial Council determined that compiling a full list of all the positions that come vacant in a year and waiting until the end of that year to allocate those positions among the eligible courts would create unnecessary uncertainty and place an added burden on courts with vacant positions by requiring that they hold open positions that may not be converted in the near term. This allocation methodology allows the Judicial Council to make an immediate determination if a court with a vacant SJO position qualifies to have the position converted.

Administrative Office of the Courts staff has been informed of two upcoming vacancies in 2008–2009 in eligible SJO positions. Based on this information and the allocation methodology described above, the attached list identifies the vacancies and proposed allocation of conversions for fiscal year 2008–2009.
