Pretrial Delays in Sexually Violent Predator Cases

This informational report to the Executive and Planning Committee is the study conducted by the Criminal Justice Services staff on pretrial delays in sexually violent predator (SVP) cases as outlined in *Camacho v. Superior Court* (2023) 15 Cal.5th 354. The report provides background on issues related to SVP case processing delays, describes the SVP commitment process, identifies potential reasons for the delays, and provides suggestions for methods to potentially reduce case processing time.
