KEY PROVISIONS OF GENERATIVE AI MODEL USE POLICY

Confidentiality & Privacy

- Submission of confidential and non-public information is prohibited
- Internal court systems exempted

Bias & Discrimination

- Use of generative AI to unlawfully discriminate is prohibited
- Biased, offensive, or harmful output must be reviewed and corrected by users

Supervision & Accountability

- Accuracy, completeness, errors, and hallucinations must be reviewed and corrected by users
- Materials are the responsibility of the person who uses or authorizes them

Transparency

 Written or visual work provided to the public requires a disclosure or watermark if a substantial portion is Al-generated



MODEL USE POLICY

Provides a template for court use:

- Can be used to comply with the planned rule of court
- Can be modified to address specific goals or operational requirements
- Courts are not required to adopt the model policy

Applies to:

- All court staff for any use of generative Al
- All judicial officers for any task outside of their adjudicative role

Does not require a court to permit the use of generative AI:

■ Courts may prohibit generative AI use entirely or may permit it with restrictions

TASK FORCE CHARGE

- Oversee the development of policy recommendations on the use of AI in the judicial branch
- Coordinate the development of proposals and potential actions by the judicial branch
- Develop its own proposals
- Coordinate with other government or judicial branch entities on AI policy developments
