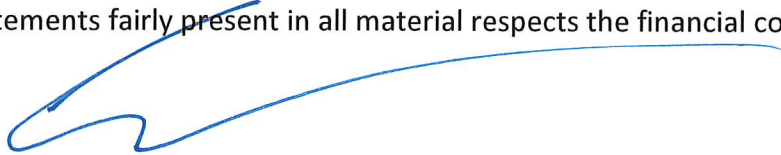


QUARTERLY FINANCIAL STATEMENT CERTIFICATION
