Statement

Dear Assembly Member de Leon:

AB 938 implements recommendations made by the Judicial Council's Blue Ribbon Commission on Children in Foster Care concerning the involvement of grandparents and other relatives of a child in dependency proceedings, and the need for parties to dependency hearings to have an opportunity to review reports and meet with legal counsel in advance of those proceedings. Specifically, this measure requires: (1) a superior court to inquire at each dependency hearing whether relatives were able to review reports and confer with legal counsel; (2) the Judicial Council to develop a form to be used by a relative of the child to provide information to the court; and (3) courts to consider the information on that form at dependency hearings.

This measure imposes additional one-time administrative costs on the Judicial Council by requiring the development of a new form to be used by courts at dependency hearings. The costs to develop and adopt the form are estimated to be minor and absorbable within existing resources. The court procedures prescribed in AB 938 are consistent with existing practice and are not expected to impose any new costs on the courts.

Dear Assembly Member Beall:

The Judicial Council is pleased to sponsor AB 938, which would require the notification of relatives when a child is removed from his or her home due to abuse or neglect, provide opportunities for relatives to provide information to the juvenile dependency court, and ensure that parties in dependency proceedings are able to confer with their attorneys in advance of court proceedings. AB 938 implements a number of the recommendations of the California Blue Ribbon Commission on Children in Foster Care. The Blue Ribbon Commission was appointed in March, 2006 by Chief Justice Ronald M. George, to make recommendations for courts and their child welfare partners to improve safety, permanency, well-being, and fairness outcomes for dependent children and their families. In its final recommendations, the Blue Ribbon Commission made numerous recommendations regarding the need to engage family members early in dependency proceedings to provide possible placements for the child and support for the family. The commission specifically addressed the need for a search for relatives to be commenced at the onset of a child welfare case. AB 938 advances those recommendations and will ensure that the court performs its oversight function in ensuring that these duties are fulfilled.

Because it was convened by the judicial branch, the commission was uniquely well situated to focus on issues of due process for parties to dependency proceedings that are not central to other discussions of foster care. As a result, many of the recommendations of the commission are intended to improve the meaningfulness of court proceedings by ensuring that all parties are well informed and able to participate in the proceedings. To advance this objective, the commission recommended that all parties be given an opportunity to consult with their attorneys in advance of hearings and have an opportunity to review reports and other important documents in the case. AB 938 will advance these recommendations by requiring court to ensure that parties have an opportunity to confer with their counsel in advance of proceedings, and clarifying the legislative intent regarding the standard for competent counsel in dependency cases. The critical decisions made by juvenile courts each day are dependent upon the information that they receive regarding the children and families that are before them. Ensuring that these parties to the case have adequate representation and can meaningfully participate in these proceedings will improve the quality of the information that court has to consider and thereby improve the quality of its decisions.

For these reasons the Judicial Council supports AB 938.
