Subject: AB 2073 (Silva), as amended April 30, 2012 – Fiscal Impact Statement

Hearing: Assembly Appropriations Committee – May 16, 2012

Dear Assembly Member Fuentes:

AB 2073 authorizes the Orange County Superior Court to establish a pilot project to require electronic filing in specified civil actions. The bill requires the Judicial Council to conduct an evaluation of this pilot project on or before December 31, 2013, and issue a report to the Legislature. Finally, the bill requires the Judicial Council to adopt rules on or before July 1, 2014, to permit the mandatory electronic filing in trial courts statewide.

Fiscal Impact

The two requirements placed on the Judicial Council by AB 2073 both create one-time costs. First, in fiscal year 2012-13, the council will be required to conduct the evaluation described in the bill on the cost of electronic filing to program participants, cost-effectiveness of the court, the effect on unrepresented parties and parties with fee waivers, and the ease of use. Taking into account data collection, contacts with e-filing vendors, contacts with other courts, determination of cost avoidance, determination of infrastructure and staff usage requirements in the pilot court, interviews or surveys of program participants, site visits, cleaning and analysis of data, etc., we estimate that it will take between 340 and 640 staff hours to conduct the evaluation and prepare the report depending on the level of rigor that would be most beneficial to the courts and the Legislature. These activities will be most appropriately performed by a research analyst (performing roughly 2/3 of the estimated workload) and a senior research analyst (performing

roughly 1/3 of the estimated workload). Using the midstep salary and benefits for each of these positions, plus overhead, it is estimated that the cost of the evaluation and report will range from \$27,740 to \$49,951.

The Judicial Council has not yet established a standard cost for rule or form development, and thus is unable to estimate here the additional cost associated with that activity for development of a rule by July 1, 2014.

Assuming the evaluation determines that the mandatory use of electronic filing in civil actions under the pilot project, or statewide pursuant to the rule of court, is cost-effective for the courts, this bill could prove to be an efficiency for courts, allowing them to better operate with the reduced resources with which they are provided. However, because trial court operations and funds for the Judicial Council / Administrative Office of the Courts are budgeted separately, efficiencies for the trial court do not offset the costs to the Judicial Council for conducting the required evaluation.

AB 2073 authorizes the Orange County Superior Court to establish a pilot project to require electronic filing in specified civil actions. Finally, the bill requires the Judicial Council to adopt rules on or before July 1, 2014, to permit the mandatory electronic filing in trial courts statewide.

The Judicial Council has not yet established a standard cost for rule or form development, and thus is unable to estimate here the additional cost associated with that activity for development of a rule by July 1, 2014.

Assuming the evaluation determines that the mandatory use of electronic filing in civil actions under the pilot project, or statewide pursuant to the rule of court, is cost-effective for the courts, this bill could highlight a significant efficiency for courts, allowing them to better operate with the reduced resources with which they are provided. However, because funds for trial court operations and the Judicial Council's Administrative Office of the Courts are budgeted separately, efficiencies for the trial courts do not offset the costs to the Judicial Council for conducting the required evaluation.
