III. DISCUSSION AND POSSIBLE ACTION ITEMS (ITEMS 1-6)

Item 1

Consideration of Budget Change Proposal (BCP) for Fiscal Year (FY) 2019-2020 Budget – Supreme Court, California Appellate Project–San Francisco. (Action Required)

Judicial Council staff request approval by the Chief Justice to move forward with an Initial Funding Request (IFR) and for council to submit a BCP for a \$350,000 increase in permanent funding for the California Appellate Project–San Francisco for fiscal year 2019-20. This request represents a 6% increase in funding for the Supreme Court’s California Appellate Project–San Francisco (CAP-SF).

Item 2

Consideration of Budget Change Proposal for FY 2019-2020 Budget—Courts of Appeal, Appellate Projects. A resubmission BCP approved by the Judicial Council for FY’s 2019-20. (Action Required)

Judicial Council staff request approval by the Administrative Presiding Justices Advisory Committee to move forward with an Initial Funding Request (IFR) and for the council to submit a BCP for an augmentation of \$1,095,000 (6%) in permanent funding for the Appellate Projects for fiscal year 2019-2020. This request represents a 6% increase in funding for the California Appellate Projects (collectively).

Item 3

Consideration of Budget Change Proposal (BCP) for FY 2019-2020 Budget—New Appellate Court Justices and staff. A resubmission of BCP approved by the Judicial Council for FYs 2015-2016, 2016-2017, 2017-2018, and 2018-19 Funding. (Action Required)

Judicial Council staff request approval by the Administrative Presiding Justices Advisory Committee to move forward with an Initial Funding Request (IFR) and for the council to submit a BCP for 2 appellate court justices, and their necessary chambers staff, for Division Two of the Fourth Appellate District to meet substantial and growing workload demands. This request will provide new permanent funding for appellate judicial recourses and chamber staff in fiscal year 2019-2020.

Item 4

Consideration of Budget Change Proposal (BCP) for FY 2019-2020 Budget—New Appellate Facilities Maintenance Program. A resubmission of BCP approved by the Judicial Council for FYs 2017-2018 and 2018-19 Funding. Funding will support Preventive and On-Demand Maintenance. (Action Required)

Judicial Council staff request approval by the Administrative Presiding Justices Advisory Committee to move forward with an Initial Funding Request (IFR) and for the council to

submit a BCP for an augmentation of \$1.3 million General Fund (\$1.2 million General Fund in 2019-20 ongoing and a one-time augmentation of \$24,000 General Fund in 2019-2020) to perform an assessment of the two state-owned, court-managed appellate court facilities and for preventative and on-demand (unforeseen repairs/replacement) maintenance in these facilities. This request will provide funds for preventative maintenance and funds will ensure that equipment is regularly inspected and maintained before a breakdown occurs.

Item 5

Consideration of Budget Change Proposal (BCP) for FY 2019-2020 Budget—Additional Appellate Court Security Recourses. A resubmission of BCP approved by the Judicial Council for FYs 2017-2018 and 2018-2019 funding. Funding will support Preventive and On-Demand Maintenance Funding for Statewide Appellate Court Security. (Action Required)

Judicial Council staff request approval by the Administrative Presiding Justices Advisory Committee to move forward with an Initial Funding Request (IFR) and for the council to submit a \$1.4 million BCP for a permanent augmentation in General Fund monies to support security services provided by the California Highway Patrol Judicial Protection Section at the Courts of Appeal. This BCP will provide an ongoing General Fund augmentation of \$1.4 million GF beginning in 2019-20 to support California Highway Patrol Judicial Protection Section (CHP-JPS) officers at appellate court locations during normal business hours. CHP-JPS's primary mission is to provide security and protection for the California Supreme Court, the California Courts of Appeal, and its personnel and facilities throughout the State.
