Subject: AB 2498 (Bonta), as amended August 15, 2016 – Oppose, unless amended

Dear Assembly Member Bonta:

The Judicial Council regretfully opposes AB 2498, unless amended, which, among other things, expands the list of criminal actions that take precedence over all other criminal actions in the order of trial to include human trafficking. The Judicial Council is opposing AB 2498, unless amended to remove this calendar preference, because the council believes the calendar preference unduly and unnecessarily intrudes upon the ability of courts to manage their calendars appropriately.

The council has historically opposed calendar preferences because courts are in the best position to prioritize cases based on the unique fact and circumstances of each individual case in the context of the other cases on the courts' dockets. The council is concerned that statutory calendar preferences mean that other cases, including cases that have statutorily mandated calendar preferences, such as juvenile cases, criminal cases, and civil cases in which a party is at risk of dying, will take longer to decide. Moreover, delays in the administration of justice that would likely result from any expansion of calendar preferences would be even more pronounced in light of the ongoing fiscal limitations faced by the judicial branch. Finally, the council notes that courts are charged with dispensing equal access to justice for each and every case on their

dockets and the calendar preference that would be established by AB 2498 would interfere with the ability of courts to do so.

For these reasons, the Judicial Council regretfully opposes AB 2498, unless amended to remove the calendar preference.
