Dear Assembly Member Wieckowski:

The Judicial Council is pleased to sponsor AB 1293, which would allow courts to charge a \$40 fee for the filing of special notices under sections 1250, 2700, and 17204 of the Probate Code. The benefit of this proposal is to help courts offset the costs of providing special notice in the specified hearings, a savings to the courts of nearly \$200,000 every year.

In December of 2011, the Judicial Council adopted legislative priorities for 2012. The first priority was to "advocate for a combination of solutions to restore some of the funding eliminated from the branch in recent years." The action included pursuing legislation to implement cost savings, efficiencies, and new revenue.

Proposals for efficiencies, costs savings, and new revenue were initially solicited from presiding judges and court executive officers. The proposals were forwarded to the Office of Governmental Affairs (OGA) to coordinate next steps. The chair of the Trial Court Presiding Judges Advisory Committee and the Court Executives Advisory Committee each appointed seven members for a 14-person PJ/CEO Trial Court Efficiencies Working Group. The proposals were circulated to the group; additional proposals were added as they were received. The group met three times, reviewing each of the proposals. The working

group recommended that roughly one-half of those proposals be forwarded on for consideration for Judicial Council sponsorship. In the meantime, the chairs of most of the council's subject matter advisory committees, the Open Courts Coalition, and the president of the California Judges Association, were asked to designate members to participate on an Ad Hoc Advisory Committee on Court Efficiencies, Cost Savings, and New Revenue. The committee was created to ensure that all of the proposals could be acted on timely, while providing the council with the benefit of the expertise of the various advisory committees. The Ad Hoc Advisory Committee met four times to review the proposals recommended by the Trial Court Efficiencies Working Group. The advisory committee further winnowed the proposals for recommendation for council sponsorship.

This past December, the Judicial Council voted to include 17 proposals for cost recovery, revenue generation and court efficiencies among the branch's legislative priorities for 2013. Of these, 11 are included in Trailer Bill Language, and several others are included in other policy bills (AB 648, AB 1352, and AB 1004). The proposal included in AB 1293, allowing courts to charge a fee for special notice, was among the 17 proposals that were vetted through the process described above, and approved for sponsorship by the Judicial Council. As a result, Judicial Council is pleased to sponsor AB 1293.
