Subject: AB 1962 (Dodd), as amended March 30, 2016 – Support, if amended

Dear Assembly Member Dodd:

The Judicial Council is pleased to support AB 1962, which requires the Department of State Hospitals to adopt guidelines establishing education and training standards for a psychiatrist or licensed psychologist to be considered by the court for appointment to conduct mental competence examinations. However, as explained more fully below, the council's support for AB 1962 is contingent upon the bill being amended to clarify that the court retains the discretion to depart from the guidelines, if necessary, in appointing such experts.

The Judicial Council appreciates your commitment to a collaborative approach with AB 1962 that involves the council and other interested stakeholder organizations in an effort to improve the quality of court-ordered mental competence examinations in cases where a defendant's competence to stand trial is at issue. However, the Judicial Council believes that the guidelines should not be binding on the courts. There may be circumstances in individual counties where there are not any psychiatrists or psychologists available that meet all of the criteria under the new guidelines. The council also contemplates situations where a proposed expert may meet

some, but not all of the new education and training standards, but has comparable experience that merits appointment as an expert in the individual case at issue.

For these reasons, the Judicial Council believes that the bill should be amended to clarify that the judicial officer retains his or her discretion in individual cases to appoint an expert whether or not the person meets the guidelines established under the bill. With the addition of such an amendment, the Judicial Council would be in full support of AB 1962.
