OPEN MEETING

Call to Order and Roll Call

The chair called the meeting to order at 1:05 PM, and took roll call.

Approval of Minutes

The advisory body reviewed and approved the minutes of the February 8, 2021, Judicial Branch Statistics Information System Subcommittee meeting.

DISCUSSION AND ACTION ITEMS

Item 1

NGI Reporting (Action Required)

Subcommittee heard presentation on possible methods of reporting Not Guilty by Reason of Insanity cases in JBSIS 4.0. Subcommittee members discussed two options: 1) continue reporting NGI cases as criminal and mental health report filings or 2) reconceptualize NGI cases as criminal filings and criminal post-disposition workload. Subcommittee members decided to retain current JBSIS 3.0 method of reporting NGI cases as criminal and mental health case filings.

Item 2

Petition Reporting (Action Required)

Subcommittee heard presentation on the methods of reporting petitions in JBSIS 3.0. Subcommittee members discussed changing petition reporting methods in JBSIS 4.0. Some potential changes included: providing additional guidance on petition reporting, providing petition reporting reference lists, and/or reclassifying some petition types. Subcommittee advised staff to continue collecting information on petition reporting in JBSIS 3.0.

Item 3

JBSIS 3.1 (Action Required)

Subcommittee discussed and approved proposal to develop JBSIS 3.1. This version of JBSIS will have the same reporting requirements as JBSIS 3.0. Courts will not need to recertify. Judicial Council staff will provide updated language and guidance to clarify reporting requirements.

Item 4

JBSIS Aging Calculations (Action Required)

Subcommittee heard proposal to add baseline aging calculations to the JBSIS 4.0 reports. Subcommittee members decided not to include baseline aging calculations in the mandated JBSIS 4.0 report.

2022 California Rules of Court

Standard 2.2. Trial court case disposition time goals

(j) Felony cases-processing time goals

Except for capital cases, all felony cases disposed of should have a total elapsed processing time of no more than one year from the defendant's first arraignment to disposition.

(Subd (j) amended effective January 1, 2007; adopted effective January 1, 2004.)

(k) Misdemeanor cases

The goals for misdemeanor cases are:

- (1) 90 percent disposed of within 30 days after the defendant's first arraignment on the complaint;
- (2) 98 percent disposed of within 90 days after the defendant's first arraignment on the complaint; and
- (3) 100 percent disposed of within 120 days after the defendant's first arraignment on the complaint.

(Subd (k) adopted effective January 1, 2004.)

(l) Felony preliminary examinations

The goal for felony cases at the time of the preliminary examination (excluding murder cases in which the prosecution seeks the death penalty) should be disposition by dismissal, by interim disposition by certified plea of guilty, or by finding of probable cause, so that:

- (1) 90 percent of cases are disposed of within 30 days after the defendant's first arraignment on the complaint;
- (2) 98 percent of cases are disposed of within 45 days after the defendant's first arraignment on the complaint; and
- (3) 100 percent of cases are disposed of within 90 days after the defendant's first arraignment on the complaint.

(Subd (l) adopted effective January 1, 2004.)

(m) Exceptional criminal cases

An exceptional criminal case is not exempt from the time goal in (j), but case progress should be separately reported under the Judicial Branch Statistical Information System (JBSIS) regulations.

(Subd (m) amended effective January 1, 2007; adopted effective January 1, 2004.)

Felony disposed case aging guidance (JBSIS 3.0)

Age of disposed preinformation cases from complaint arraignment to final or interim disposition Report the number of cases that, in a stage prior to the filing of an information, were disposed (final or interim), and in which the defendant was arraigned on a complaint. Age from complaint arraignment date to final or interim disposition date

Age of disposed cases from date of complaint arraignment Report the number of cases that were disposed, in which informations were filed and defendants were arraigned on informations. In this section, age from complaint arraignment date to final disposition date

Age of disposed cases from date of arraignment on the information or indictment Report the number of cases that were disposed, in which informations or indictments were filed, and defendants were arraigned on the informations or indictments. In this section, age from information or indictment arraignment date to final disposition date.
