- 3. The maximum amount that the Judicial Council may pay Contractor under this Amendment is: \$0.00.

  The maximum amount that the Judicial Council may pay Contractor under this Agreement, including this Amendment, remains at \$0.00
- 4. The parties agree to amend the Agreement for Security Screening Equipment and Maintenance as follows:
  - a) Extend the expiration date of the Agreement from 09/14/2025 to 09/14/2026 by exercising one (1) of the additional one (1) year options to extend (the "Option Term"), per the Standard Agreement Coversheet, Item 2;
  - b) Increase the rates of non-maintenance services of the Agreement for the Subsequent Term as allowed per Exhibit C, section 1 (maximum 3% adjustment of the current price); and
  - c) Delete the existing Exhibit E in its entirety and replace it with Exhibit E Revision 1, modifying all non-maintenance rates.
- 5. Except as provided in this Amendment, all terms and conditions of the Agreement (as previously amended, if applicable) remain in full force and effect.
