1. All capitalized terms not defined in this amendment (the "Amendment") have the meanings given to them in the Agreement referenced above. As set forth in the Agreement, the term "Contractor" refers to **CEIA USA, LTD.**, and the term "Establishing Judicial Branch Entity", "Establishing JBE" or "Judicial Council" refers to the **Judicial Council of California**.
2. This Amendment becomes effective on 09/13/2025 ("Amendment Effective Date").
3. The maximum amount that the Judicial Council may pay Contractor under this Amendment is: \$0.00.
The maximum amount that the Judicial Council may pay Contractor under this Agreement, including this Amendment, remains at \$0.00.
4. The parties agree to amend the Agreement for Security Screening Equipment and Maintenance as follows:
 - a) Extend the expiration date of the Agreement from 09/14/2025 to 09/14/2026 by exercising one (1) of the additional one (1) year options to extend (the "Option Term"), per the Standard Agreement Coversheet, Item 2;
 - b) Increase the rates of non-maintenance services of the Agreement for the Subsequent Term as allowed per Exhibit C, section 1 (maximum 3% adjustment of the current price); and
 - c) Delete the existing Exhibit E in its entirety and replace it with Exhibit E – Revision 1, modifying all non-maintenance rates.
5. Except as provided in this Amendment, all terms and conditions of the Agreement (as previously amended, if applicable) remain in full force and effect.
