# DISCUSSION AND ACTION ITEMS (ITEMS 1-2)

#### Item 1

#### Naming Request for the New Criminal Courthouse in Santa Rosa

Mr. Chris Magnusson presented the request from the Superior Court of California, County of Sonoma, indicating the following:

- The new criminal courthouse project for the Superior Court of Sonoma County was originally authorized and funded under the SB 1407 bond bill and has remained in active status.
- The project is currently in Working Drawings and has been authorized for Construction funding through the passage of the 2018 Budget Act.
- The project will complete its Working Drawings phase in January 2020.

- To assist this project with the design and future fabrication of signage based on its schedule, the court has asked that it be allowed to proceed with the name as proposed in the meeting materials.
- The proposed name complies with the Judicial Council's *Courthouse Naming Policy* for names by location and case type (under section III.B.2.a) shown on page 2 of the policy in the meeting materials. Owing to its compliance, it is recommended the committee make a recommendation to the Judicial Council for final action/approval.

#### Action:

The subcommittee—with exception of its absent member shown above—voted unanimously on the following motion:

1. Recommend the Judicial Council approve the request for naming the new criminal courthouse as the *Hall of Justice, Superior Court of California, County of Sonoma*.

#### Item 2

### Naming Request for the New Civil Courthouse in Menifee

Mr. Chris Magnusson presented the request from the Superior Court of California, County of Riverside, making the exact statements (captured above for the Sonoma project) for the new civil courthouse project.

#### Action:

The subcommittee—with exception of its absent member shown above—voted unanimously on the following motion:

1. Recommend the Judicial Council approve the request for naming the new civil courthouse as the *Menifee Justice Center, Superior Court of California, Riverside County*.
