DISCUSSION AND ACTION ITEMS (ITEM 1)

Item 1

Reassessment of Trial Court Capital-Outlay Projects

Summary: As this advisory committee meeting had been broadcasted live via webcast video, the archived webcast video for this portion of the meeting is available at http://jcc.granicus.com/player/clip/1314.

Senate Bill 847 (Committee on Budget and Fiscal Review) revised Government Code section 70371.9 to require the Judicial Council to update its 2008 prioritization methodology as well as to reassess all trial court capital-outlay projects that had not been fully funded up to and through the 2018 Budget Act (FY 2018-19). This reassessment was due to the Legislature by December 31, 2019.

The advisory committee reviewed Judicial Council Facilities Services' progress on the reassessment of trial court capital-outlay projects and recommendation to move the reassessment documents forward for Judicial Council review/action. The following was discussed: (1) extensive public comments received on the draft Revision of Prioritization Methodology for Trial Court Capital-Outlay Projects and draft statewide list of capital projects (prioritized on needsbased/cost-based scores per the council's updated draft prioritization methodology) reviewed at the advisory committee's meeting on August 29, 2019, and posted subsequently for comment, (2) finalization of Court Facility Plans for all 58 trial courts, (3) final updates to the council's

draft prioritization methodology, and (4) final updates to the draft statewide list of capital projects.

Mr. Mike Courtney and Ms. Pella McCormick presented this item consistent with materials that were posted online for public viewing in advance of the meeting and available at www.courts.ca.gov/documents/cfac-20191001-materials.pdf.

Action: The advisory committee—with the exceptions of judges Donald Cole Byrd and William F. Highberger, as Ex-Officio, non-voting members, and the members who were absent as shown above—voted unanimously to approve the following motions:

- 1. Approve the final draft versions of the revised prioritization methodology and statewide list of capital projects for submission to the Judicial Council for adoption at its meeting in November 2019.
- 2. Delegate to the CFAC chair and vice-chair the review of the report to the Judicial Council.
