Item I: Draft Annual Agenda Review

Description of Item Discussed

Judge Vlavianos welcomed everyone. There were no comments received from members of the public prior to this meeting. Ms. Nancy Taylor, Manager at the Center for Families, Children & the Courts went through each of the items in the Annual Agenda and asked the committee members for their feedback.

Action:

• The key objectives are similar to much of the work already started last year. There are no significant changes on this area.

- Proposition 47 to be added after recidivism reduction funding on item 4 because of the financial impact it will cause next year.

- Item 2: change the focus on intern program and local court funding as separate items. The committee agreed to combine both items.
- Item 3: there were no changes on this item.
- Item 4: pretrial supervision and reentry programs will be included on this item after Diversion.
- Item 5: recidivism reduction will be added on this item.
- Item 6 on the annual agenda will have an added policy subcommittee to review legislative proposals and items of policy-related nature.
