Veterans Treatment Court (VTC) Strategic Plan

Strategic Plan

- The subcommittee noted what a great resource the CACC website was and want to ensure the link goes out to all California Judges, highlighting the resources available.

Item 2

Inviting Dr. Jack Tsai and Dr. Andrea Finlay to September's subcommittee meeting

- The Chair was made aware of a research article written by Dr. Jack Tsai, Dr. Finlay and others. The article, Diversion of Veterans with Criminal Justice Involvement to Treatment Courts: Participant Characteristics and Outcomes, is of great relevance to our subcommittee and to the work of many of its members.
- The subcommittee discussed the concerns of the previous guest, Mr. Anthony Noriega of the League of United Latin American Citizens (LULAC) who discussed his concerns that there remain barriers to LatinX veterans in the Courts, but the subcommittee could not comment on this point as there were few race and ethnicity statistics to reference.
- The subcommittee agreed to invite Dr. Tsai and Dr. Finlay to the next subcommittee meeting. The Chair asked the subcommittee to consider questions they would like to pose and forward them to JCC staff to be sent to the guests ahead of the next meeting
