Develop rules to implement Penal Code section 1368.1(a)(2), which allows the prosecuting attorney to seek a determination of probable cause for a defendant who is incompetent to stand trial if the complaint charges specified offenses and the probable cause determination is sought solely for the purpose of establishing that the defendant is gravely disabled.
