Call to Order and Roll Call

Info 1 Membership/Staffing

Staff reported three changes to the roster on page 1 of the materials: the Center for Judicial Research and Education Advisory Committee Liaison is vacant, Trial Court Presiding Judges Advisory Committee Liaison is now Assistant Presiding Judge Yabuno of San Bernardino, and Facilities Services Liaison Pella McCormick's title changed from Acting Director to Director.

Staff reported one change to the solicitation for nominations: a trial court judicial administrator position was added as member Kimberly Flener is retiring at the beginning of September 2021. Judge Olmedo welcomed Judge Yabuno and thanked Ms. Flener for her work on the committee.

Staff also provided an update on the analyst the Emergency Planning and Security Coordination Unit hired to take over the emergency planning programs and services that the unit provides.Carolynn Bernabe's contact information was added to the unit's Judicial Resources Network program page (<https://jrn.courts.ca.gov/programs/security/>) and will be emailed to members.

Info 2 Annual Agenda

Staff provided an update on the annual agenda, which proposed committee projects for 2021. Chairs were asked to prioritize projects that assist with access to justice during the pandemic, address otherwise urgent needs, or are mandated by legislation. A correction should be made to Project 2 on page 7 of the materials: the Screening Equipment Replacement Program should have been updated to show a \$1.8m budget for fiscal year 2020 to 2021. Staff will follow up.
