INFORMATIONAL ITEMS (ITEMS 1-3)

Item 1

Resource Assessment Study (RAS): Time Study Overview

Presenter(s): Ms. Suzanne Tallarico, National Center for State Courts

Mr. Nicholas Armstrong, Judicial Council

Mr. Armstrong introduced Ms. Tallarico of the National Center for State Courts, who presented on the process of conducting a court staff time study. Ms. Tallarico demonstrated the data collection tool that court participants will use and covered various aspects of the time study process, including pre-study training, data collection procedures, help desk support, data analysis, and the role of supplemental qualitative data collection.

Item 2

RAS Time Study Court Participation Update and Next Step

Presenter(s): Mr. Nicholas Armstrong, Judicial Council

Mr. Armstrong provided an update on the courts confirmed to participate in the upcoming RAS time study. He presented an overview of the selection process, highlighting the use of various data points, including geography, cluster distribution, number of courthouses, and language access needs within each county. Mr. Armstrong demonstrated how these factors collectively show the court sample effectively represents the state's overall diversity and operational differences.

Item 3

Public Data Dashboards

Presenter(s): Mr. Jake Chatters, Superior Court of Placer County
Ms. Leah Rose-Goodwin, Judicial Council

Mr. Chatters discussed key governance considerations for developing public data dashboards and dynamic data tools. He outlined the implementation of a structured governance process that includes drafting a data proposal, ensuring compliance with established data policies, and conducting reviews with relevant committees. This approach is designed to maintain data accuracy, control access, and ensure the data is prepared to address public inquiries effectively.
