### Item 1

## **Cochair Report**

Presenters: Hon. Abby Abinanti, Chief Judge of the Yurok Tribal Court, Cochair of the California Tribal Court–State Court Forum, Hon. Joyce D. Hinrichs, Judge of the Superior Court of California, Court of Humboldt, Cochair of the California Tribal Court–State Court Forum.

Judge Joyce Hinrichs informed the Forum of the upcoming Cow County Institute on June 26-28, 2024 and invited members to provide input on what they think attendees should learn about tribal issues.

Ms. Ann Gilmour noted that the Forum annual agenda for 2024 had been approved by the Executive and Planning Committee and was included in the meeting materials. She also noted that the proposal for recognition and enforcement of tribal court child custody orders is currently out for public comment.

The open session of the meeting was paused at 12:23 p.m. to discuss item 1 of the closed session. Open session was resumed at 1:06 p.m.

#### Item 2

### State of Alaska Model

Presenter: Hon. Eric Smith (Ret.), Alaska Superior Court

Judge Eric Smith presented to committee members several practices in Alaska related to crossjurisdictional collaboration in criminal justice cases. Judge Smith also discussed his experience with the use of sentencing circles and sentencing recommendations from tribes.

Judge Abby Abinanti suggested that a training on this subject, and perhaps a pilot project, be created to see if this model can be duplicated in California.
