Subject: Assembly Bill 1384 (Nguyen), as amended August 28, 2025—Request to Veto

Dear Governor Newsom:

The Judicial Council respectfully requests your veto on Assembly Bill 1384 because it limits the court's authority to set a later hearing for a noticed motion in an action for unlawful detainer involving a commercial tenancy.

The council acknowledges the narrowing amendments taken on the Senate floor, but the bill nevertheless requires courts to hear commercial unlawful detainer cases within ten court days after the first date set for a hearing on the motion. Our courts already have heavily impacted calendars which have only been compounded by a bevy of legislatively mandated accelerated calendaring requirements. Courts need to retain the flexibility to prioritize matters impacting safety and basic needs such as domestic violence restraining orders, gun violence restraining orders, and wage theft claims over other civil matters.

Because this bill would significantly impinge on a court's discretion to set a later hearing date for commercial evictions, the Judicial Council is opposed to AB 1384 and respectfully requests that you veto the bill.
