On January 25, 2018, the Information Technology Advisory Committee's (ITAC) Rules and Policy Subcommittee (RPS) recommended circulating for public comment a form proposal for a new form for withdrawal of consent to electronic service. The proposal is a joint proposal with the Civil and Small Claims Advisory Committee (CSCAC) and purpose of the proposed form is to comply with Code of Civil Procedure section 1010.6. The form proposal will be presented to ITAC on February 2, 2018, and the Judicial Council Technology Committee (JCTC) on February 5, 2018.

The original materials submitted for the ITAC and JCTC meetings contain the version of the form that RPS reviewed. However, subsequent to the RPS meeting, on January 31, 2018, CSCAC's Rules and Forms Subcommittee recommended circulating a revised version of the form. The revisions to the proposed form are minor and improve the clarity of the form and make the language more consistent with Judicial Council style guidelines. The revised version of the proposed form is attached to this memorandum.
