Third-Party Administrator Annual Audit (Action Required)

Mr. Alan Turnipseed, Senior Vice President, Marsh Advisory, presented the Judicial Branch Worker's Compensation Program Audit Results. Evaluation of 2020-2021 performance across 14 distinct audit categories were discussed. A comparison of 2020-2021 performance against the prior year baseline audit was presented. Areas of opportunity to enhance overall Program

performance was introduced as well as strategic recommendations to ensure future compliance on areas which scored ≥90%.

With no further discussion or comments, Ms. Shelby Wineinger called for a motion on whether to adopt the audit report.

AIMS Annual Stewardship Report (No Action Required)

Ms. Beth Harville, Program Manager, AIMS presented prior and current year closing ratio as well as a five-year history of open claims and settlements, total temporary disability benefits paid, history of total and average medical paid per claim, litigation ratio for current fiscal year, and a breakdown of legal costs for the fiscal year. Mr. Dominic Russo (Chief Executive Officer) AIMS, thanked the Program for their partnership and the Chair acknowledged and thanked Mr. Russo, Ms. Harville, and the AIMS team for their contribution over the years.

Presentation of Draft Actuarial Report and Premium Allocation Results for FY2022-23 (No Action Required)

Ms. Becky Richard, Senior Manager, Bickmore Actuarial presented the estimate for outstanding liabilities for both programs as of June 30, 2022 as well as funding projections for 2022-2023. Ms. Richard provided a brief review of commonly used terminology surrounding the actuarial result. Ms. Richard presented that the overall claims in the Trial Courts have been settling for less than anticipated which is consistent with previous years. Overall claims paid for the Judiciary program were also less than anticipated. It was reported that the JBWCP available assets have grown since the previous analysis. In addition, the liability estimates have been lowered which shows that the Program is in a surplus position. The Chair informed the board that the numbers presented by Ms. Richard were estimates and that at the next meeting in March, Ms. Richard will have updated figures for the board to discuss.
