**2. Consent Item**

Action on Pending Legislation

a) AB 1712 (Beall), as amended April 26, 2012 – Minors and nonminor dependents: out-of-home placement

Contains numerous technical and clarifying amendments to implement the provisions of AB 12 (Beall and Bass, Ch. 559, Stats. of 2010). These include: (1) clarifying that a CASA can serve a nonminor dependent; (2) clarifying that a nonminor delinquent in a foster care placement to accomplish his or her rehabilitative goals cannot be required to complete a mutual agreement to be a nonminor dependent, but remains subject to the jurisdiction and authority of the delinquency court; (3) clarifying competency provisions relating to nonminor dependents; (4) clarifying that nonminor dependent Indian children may participate in tribal customary adoptions; (5) authorizing adult adoption as a permanent plan for nonminor dependents; (6) establishing a framework to transfer the case of a nonminor dependent if he or she has established residency in a new county based upon residency in the county for at least a year; (7) allowing nonminor dependents who turn age 19 in 2012 to remain in care or to re-enter care; (8) expanding the definition of relative for purposes of Kinship

Guardianship Assistance Program (Kin-GAP) eligibility; and (9) clarifying the educational and health care privacy rights of the nonminor dependent.

**PCLC Action:** Support.

- b) AB 2299 (Feuer), as amended May 3, 2012 – Local government: public safety officials: confidentiality  
Authorizes the board of supervisors of a county to establish a program whereby the names of certain public safety officials, including judges and subordinate judicial officers, may be redacted upon request from any property record of a principal residence that is disclosed to the public by that county.

**PCLC Action:** Support.

- c) AB 2393 (Davis), as amended March 29, 2012 – Family law: child support formula  
Increases the net disposable income adjustment for low-income child support obligors from \$1,000 to \$1,500, and directs the Judicial Council to calculate an annual adjustment to that amount each March 1 based upon the change in the California Consumer Price Index.

- d) SB 1433 (Alquist), as amended April 11, 2012 – Domestic violence: protective orders  
Modifies existing statutory requirements concerning firearms relinquishment in cases in which a Domestic Violence Prevention Act (DVPA) protective order has been issued to: (1) require courts to conduct a search to determine if the restrained person has a registered firearm when the court is performing other required criminal history searches on the party to be restrained by the order, subject to the availability of resources for this task; (2) require law enforcement officers who serve DVPA orders to request that a restrained person surrender his or her firearm when the order indicates that the party might have a gun; (3) require the restrained party to file a copy of the form filed with the court documenting the surrender of the firearm with the law enforcement agency that served the order; and (4) require a peace officer serving a DVPA protective order to take temporary custody of any firearm in plain sight or discovered pursuant to a lawful search as necessary to protect the peace officer or other person present.

### 3. Discussion Items

#### Action on Pending Legislation

- a) AB 2442 (Williams), as amended April 25, 2012 – State property: California Hope Public Trust

Establishes the California Hope Public Trust to support the California State University, the University of California, and the California Community Colleges systems. Requires the Trust to annually submit a request to the Legislature to enact legislation that would authorize the Trust to control the state-owned real property the Trust determines it should control, including court facilities. Provides that the Trust may manage the properties it controls in a variety of ways including: disposition; construction and maintenance; leasing; entering into joint ventures with other entities for construction or development of buildings and land for joint-use purposes; issuing revenue bonds to obtain funds to pay the cost of projects involving the property; and contracting with DGS for the management and maintenance of property in possession of the Trust.

**PCLC Action:** Oppose unless amended to exempt all property controlled and managed by the judicial branch.

b) **Trailer bill language: Court security funding realignment cleanup trailer bill legislation**

Amends the Superior Court Law Enforcement Act of 2002 to reflect the changed relationship between courts, counties, and sheriffs in light of the realignment of court security funding implemented as part of the 2011-12 budget (AB 118, Stats. 2011, ch. 40). Among other things, the proposed bill: (1) expressly states that “[a]lthough realignment changed the source of funding for court security,” it did not, and the amendments by this bill are not intended to and should not “result in reduced court security service delivery, increased obligations on sheriffs or counties, other significant programmatic changes that would not otherwise have occurred absent realignment”; (2) clarifies that courts generally are not responsible for and shall not pay sheriffs for costs of security, except that a court may pay for increased services that the sheriff would not have been obligated to provide absent realignment, and thus are not required to provide subsequent to realignment; (3) eliminates the distinction between “allowable” and “unallowable” costs, as the sheriffs are limited only by the requirement that all revenue in the Local Trial Court Security accounts be spent on trial court security and by the language described in (1), above.

#### Invitation to Comment

- d) Probate Guardianships: Referral of Proposed Ward in a Guardianship Proceeding to County Child Welfare Department for an Investigation of the Ward's Status as a Dependent Child Under the Juvenile Court Law  
Reconciles recent appellate court decisions and clarifies the respective responsibilities of guardianship and juvenile courts and county child welfare departments concerning proposed wards who also may qualify as dependent children of the juvenile court.

#### Action on pending legislation

- a) AB 2073 (Silva), as amended April 30, 2012 – Courts: electronic filing and service of documents in the trial courts  
Authorizes the Orange County Superior Court, until July 1, 2014, to adopt a local rule of court that would establish a pilot project mandating parties to civil actions identified by the court to electronically file and serve documents. Requires the Judicial Council to conduct an evaluation of the pilot project and report to the Legislature, on or before December 31, 2013, on the results of the evaluation. Requires the Judicial Council, on or before July 1, 2014, to adopt uniform rules that would permit trial courts throughout the state to mandate electronic filing and service of documents in civil cases.

**PCLC Action: Support.**

- b) AB 2076 (Ma), as amended May 25, 2012 – Official court reporter fee  
Provides that fees charged and collected by courts for the cost of providing a court reporter in civil cases are to be retained by the court in which the fee was collected. Directs trial courts to assess a flat \$30 fee for the services of a court reporter in civil proceedings lasting for less than one hour. Provides that the \$30 of the civil filing fee which is to be used for the services of an official court reporter in civil proceedings shall be retained by the trial court. Repeals existing statutory language which authorizes the Judicial Council to allocate revenues from the portion of the filing fees that is intended for court reporters in civil proceedings to replace reductions in the General Fund appropriation to the trial courts.

**PCLC Action: 1) No position on the issue of whether courts should be able to retain the court reporter fees assessed and collected, pending action of the Trial**

Court Budget Working Group. 2) Oppose the repeal of statutory language which allows the Judicial Council to redirect the filing fee revenue to replace reductions in the General Fund appropriation to the Trial Court Trust Fund. 3) No position on the provision requiring courts to assess a flat \$30 fee for court reporter services in proceedings lasting less than one hour, pending action of the Trial Court Budget Working Group. 4) Consistent with recommendation #2 and existing law, oppose the requirement that directs \$30 of each filing fee be retained by the trial court, instead of remitted to the Trial Court Trust Fund, for the purposes of providing court reporters in civil proceedings.

Establishes the California Hope Public Trust (Trust) to support instruction and direct student services at the California State University (CSU), the University of California (UC), and the California Community Colleges (CCC) systems.

Requires the Trust to manage properties transferred to it with the goal of increasing their value and that the Trust use the moneys generated from managing the properties to support the CSU, UC, and CCC systems.

Contains no exemption for any court facilities for which the Judicial Council has authority to manage and control pursuant to the Trial Court Facilities Act of 2002 (Stats. 2002, ch. 1082).

**PCLC Action:** Defer action, and direct OGA to work with PCLC members Judge Mary Ann O'Malley and Ms. Kim Turner on proposed language to submit to the author, to protect Judicial Branch property.

#### **4. Informational Item**

- a) Curtis Child reported on a potential proposal arising out of Fresno relating to video appearances in traffic and juveniles. Andi Liebenbaum provided an overview on SB 210 relating to OR release and the likely possibility the bill will come to PCLC with a recommendation to oppose from the Criminal Law Advisory Committee and potential PCLC action in the near future.
