Executive Summary

The Governing Committee of the Center for Judicial Education and Research (CJER) has completed the final report on its 2010–2012 education plan for the judicial branch and the audiences the CJER Governing Committee serves (see Attachment A). The final report provides an overview on the education plan’s execution and the extent to which it met the educational objectives established by the CJER Governing Committee.

Previous Council Action

Promulgation of this education plan was part of the larger education development redesign the CJER Governing Committee implemented in 2010 as part of its Annual Agenda.

Methodology and Process

This two-year education plan was the first of its kind for the governing committee and was presented to the Judicial Council in 2010 as a means of informing the council of the education activities being undertaken by the governing committee. (When the education plan was initially developed, existing educational obligations had to be merged into the education plan.) To ensure a smooth transition to this new model and to ensure that the education plan was being executed properly, CJER staff developed a reporting and tracking protocol to confirm that all of the items

in the education plan were being developed and delivered as scheduled and that any deviations from the plan, of either the delivery schedule or the delivery method, were noted, explained, and where appropriate brought to the attention of the relevant curriculum committee(s) and the governing committee for appropriate action.

For example, the cancellation of the Appellate Justice Institute in 2011 required the Appellate Practice Curriculum Committee to review the planned content for that program and determine what other methods of delivery could be employed to ensure that this education was delivered to this audience. (A combination of videoconferences and local programming was ultimately employed.) Other deviations from the education plan—a change in the delivery year of a product or the change in content of a class or program, for example—would similarly require the review and approval of the relevant curriculum committee. These deviations are noted in the final report summary sheet as being referred to the committees.

Less consequential alterations to the education plan, such as rearranging the broadcast production schedule within an education plan year or renaming a particular regional class, were delegated to staff to handle. Finally, staff reported to the governing committee on the status of the education plan every six months.

Summary of Findings

In sum, the results are exceptional. As the plan’s statistical summary reveals, the vast majority of all the educational products developed during 2010–2012 were delivered on schedule. These products included statewide live events, regional programming, online courses, broadcasts, webinars, and CJER’s extensive array of publications. The plan’s final report also illustrates the flexibility of the current education development model, as when education products had to be redesigned in response to extenuating circumstances (e.g., budget reductions, staff departures) but nevertheless were ultimately educationally sound, even if delivered in a different format. The final report on the 2010–2012 education plan also demonstrates how the governing committee’s education development model lends accountability and transparency to the development and delivery of education to the audiences within the judicial branch.

Scale of the education plan

More than 300 separate live programs for judicial branch audiences—a total of all statewide, regional, and local live programming—were scheduled during 2010–2012. Of this number, only 31 (approximately 10 percent) were cancelled. Cancellations resulted from funding or staffing reductions, faculty unavailability, or low enrollment (often because of a lack of judicial appointments). Similarly, 95 separate broadcasts were scheduled and 18 videoconferences (with only one cancellation each), as well as several webinars. This latter delivery method has expanded greatly in the past year, and CJER is now delivering much more education using this technology.

During the past several years, with reductions in live face-to-face programs, distance education has played a larger role in providing education to judges and court staff. The websites Serranus

and COMET (Court Online Mentoring, Education, and Training), for court staff, have become the largest delivery mechanisms for judicial branch education. Consequently, the 2010–2012 education plan contained 64 video products specifically designed for the Serranus and COMET websites, as well as 30 videotaped courses from live programs. One of the most productive areas in this education plan centered on judicial job aids. During the development of this education plan, several curriculum committees requested that CJER publications be reviewed and specific items, such as checklists and scripts, be extracted from these resources to create various job aids. A workgroup was appointed and worked with staff, producing more than 90 job aids covering all of the major substantive areas (criminal, civil, juvenile, family, and probate). A similar project is currently nearing completion for court staff.

Scope of the education plan

The 2010–2012 education plan has an enormous amount of variety in content and subject areas. In addition to the standard programs and products CJER has delivered for many years—including the Judicial College, the judicial institutes, the statewide and regional court staff classes, and the *Great Minds* and *Continuing the Dialogue* broadcasts—the 2010–2012 education plan introduced new topics, such as evidence-based practices, and incorporated this content into various criminal, family, and juvenile law programs and courses, as well as programs devoted to court leadership. A new video series on the Lanterman–Petris–Short Act covers issues such as gun returns, shock therapy, and developmental disabilities. New courses and distance education products were developed during this period in response to requests from the curriculum committees, including evidence in civil and criminal cases, ethical issues, and social media.

For court staff, many programs, broadcasts, and other education products were delivered on topics such as caseload management in various court assignments, basic procedures in traffic and felony sentencing, and employee motivation, communication skills, and professional ethics for court management. Finally, using WebEx technology, skill-based courses such as writing and editing—traditionally live face-to-face events—were delivered much more economically while retaining their effectiveness.

Next Steps

Transitioning to the new education development model and successfully executing the 2010–2012 education plan have been tremendously instructive experiences for the CJER governing committee and staff. The tracking and monitoring processes put in place by staff will ensure a successful execution of this current plan.

Relevant Strategic Plan Goals and Operational Plan Objectives

This report furthers Goal V, Education for Branchwide Professional Excellence, specifically by providing relevant and accessible education and professional development opportunities for all judicial officers and court staff.
