¹ Note: Effective July 1, 2013, Presiding Judge Laurie M. Earl, Ms. Mary Beth Todd, and Mr. David H. Yamasaki will begin a 1 year term on the Judicial Council Trial Court Budget Advisory Committee while serving as a member of the Judicial Council. Rule 10.2(e), of the California Rules of Court provides that neither council members nor nonvoting advisory council members may concurrently serve on both the council and an advisory committee unless waived by the Chief Justice. Presiding Judge Earl's current term on the Judicial Council will end on September 14, 2013. Ms. Todd's current term on the Judicial Council will end on September 14, 2015. Mr. Yamasaki current term on the Judicial Council will end on September 14, 2014. By waiver of California Rules of Court, rule 10.2(e), Presiding Judge Earl, Ms. Todd, and Mr. Yamasaki may commence and serve out their terms on the Judicial Council Trial Court Budget Advisory Committee while serving as a member of the Judicial Council.


