Social workers, legal scholars, and Indigenous rights advocates have long described the Indian Child Welfare Act as the "gold standard" for handling foster care cases. But Minnesota attorney Mark Fiddler has focused much of the past decade on dogged attempts to dismantle the law known as ICWA, which aims to preserve Indigenous families and tribes by prioritizing placements with kin. Fiddler, an enrolled member of the Turtle Mountain Band of Chippewa Indians, has litigated such cases before the U.S. Supreme Court and in numerous state and federal courts nationwide. Yet the longtime ICWA opponent has a surprising background. He is also the founding director of the Minneapolis-based ICWA Law Center, an influential pro bono firm providing legal services and advocacy to "strengthen, preserve and reunite Indian families, consistent with the mandates and spirit of the Indian Child Welfare Act."

These programs are supported with funds from the Office on Violence Against Women, U.S. Department of Justice that are administered through the Governor's Office of Emergency Services (CalOES), the U.S. Department of Health and Human Services, Court Improvement Program, and the California Department of Social Services.

Bill creating Indian Child Advisory Council signed into law

Gov. Kristi Noem has signed a bill creating a South Dakota Indian Child Advisory Council. The bill places the council within the Department of Social Service. Its goal is to improve communication and cooperation between tribes and the state when it comes to developing policies to improve Native child welfare.

Prioritizing and directing resources to American Indian and Alaskan Native (AI/AN) programs to implement, expand, and/or enhance their Head Start services to tribal children and families is critical for meeting federal trust responsibility; preserving, and promoting Native language, culture, and traditions; and addressing the impact of historical trauma on Native Americans. As part of the Administration for Children and Families' (ACF) commitment to partnering with tribal nations to provide high-quality Head Start programming, in addition to regular tribal consultations, the Office of Head Start (OHS) invites public comment on the rules, regulations, and available training and technical assistance (TTA) supports impacting the AI/AN Head Start community. This Request for Information (RFI) seeks input on topics including eligibility; program options; quality environments; child health and safety; tribal language preservation, maintenance, revitalization, and restoration; family and community engagement; workforce; training and technical assistance; partnerships with state systems; facilities; fiscal operations; early childhood systems; and others, to improve the quality of Head Start services in areas of great need and affirm the federal government's commitment to protect Native communities.

Are we living up to our obligations to protect Native American rights and Tribal sovereignty? with John Echohawk (Podcast)

[SB 6146](#) would authorize Washington state law enforcement officers to enforce warrants issued by Washington’s 29 federally recognized tribes and empower them to transport people to tribal lands for prosecution.

[Biden-Harris Administration Announces Two Head Start Changes to Serve More Children in Tribal Communities and Children of Agricultural Workers](#) (Press release)

U.S. Department of Health and Human Services - March 29, 2024

On March 23, 2024, President Biden signed into law provisions giving Head Start programs additional flexibility to serve children in Tribal communities and children of farmworkers. Both of these new provisions ensure Head Start programs can more effectively serve the families for whom they were designed. First, Tribally run Head Start programs will be able to prioritize enrolling children from the Tribe, or who live with Tribal members, regardless of family income. This change will allow Tribal Head Start Programs--which are a precious source of child care and Native language preservation in hundreds of Native communities--to grow to meet the existing demand in their communities without losing federal funding eligibility. In addition, any child who has at least one family member primarily engaged in agricultural employment is now eligible for Migrant and Seasonal Head Start.

Congress created the independent Alyce Spotted Bear and Walter Soboleff Commission on Native Children in 2016 to conduct a comprehensive study of the programs, grants, and supports available to American Indians, Alaska Natives, and Native Hawaiians from birth through age 24 and with making recommendations about how this overall system could be strengthened, improved, and where needed, transformed to better help Native children and youth thrive. The Commission’s research addressed issues of child welfare; juvenile justice; education from early childhood through post-secondary and vocational training; physical, mental, and behavioral health; and research and data. It presents the multiple ways in which these different areas intersect to challenge life circumstances for Native children and youth. The Way Forward provides both broad principles and actionable steps to be taken to achieve the Commission’s goals to improve outcomes for Native children and youth and set them on the path to thriving.

[The Consequences of Mythology: Supreme Court Decisionmaking in Indian Country](#), Alexander Pearl, 71 UCLA Law Review Rev. 6 (2024)

Ilanoli isht unowa. We tell our own stories. A single historical event has many stories. Although this nation’s official chronicle expected and even hoped for Indigenous peoples to fade away, we are still here. Our histories are marked by resistance, survival, sovereignty, and renaissance. Only now, in the later stages of the American experiment, do our histories have the chance to matter in new forms and spaces.

[The civilization canon: Common law, legislation, and the case of Hawaiian adoption](#), Jose Argueta Funes 71 UCLA Law Review Rev. 128

Recently, scholars have uncovered many ways in which our traditional understandings of the U.S. Constitution have failed to grapple with American empire and colonialism. This work has shown that the nation’s history of mistreating Indigenous peoples is constitutive of its legal order. In this Article, I provide evidence of a similar kind of imperialistic effect in the realm of statutory interpretation. To the extent there is a conventional understanding about statutory interpretation, it does not attach special significance to the demands of empire. But much like American constitutional design, statutory interpretation has not been neutral with respect to imperial expansion and colonization.

Indians - sovereign immunity: The U.S. Supreme Court's interpretation of the Bankruptcy Code, Erin Weightman 99 N.D.L. Rev. 195

In *Lac du Flambeau Band of Lake Superior Chippewa Indians v. Coughlin*, the U.S. Supreme Court addressed whether the Bankruptcy Code expressly abrogates sovereign immunity for federally recognized Indian tribes in bankruptcy proceedings.

Section 4(c)(2)(C) Response of the Departments of Justice and the Interior to Not One More: Findings and Recommendations of the Not Invisible Act Commission Pursuant to Public Law 116-166, U.S. Department of Justice, March 2024

The Not Invisible Act (P.L. 116-166) was enacted on October 10, 2020, to increase intergovernmental coordination in identifying and combatting violent crime within Indian lands and against American Indian and Alaska Native (AI/AN) people.¹ The Act was the first piece of legislation in history introduced—and subsequently enacted—by a group of four members of Congress who were each enrolled in federally recognized Tribes. The effort was led by then Congresswoman Deb Haaland (NM-01) during the 116th United States Congress.

Tribal Court Jurisdiction and the Exhausting Nature of Federal Court Interference, Kekek Jason Stark, 92 U. Cin. L. Rev. 701 (2024)

It is a general principle of federal Indian law that matters of tribal law should properly be interpreted by tribal courts. However, when it comes to questions of tribal jurisdiction, as a matter of federal common law, the United States Supreme Court imagined the authority to review tribal court determinations of jurisdiction. With this authority, the United States Supreme Court simultaneously created the tribal exhaustion doctrine, which established that tribal courts should have the first opportunity to evaluate the factual and legal bases for a challenge to their own jurisdiction.

The Health and Well-Being of American Indian and Alaska Native Children: A History of Inequity and a Path Forward, Children's Bureau Express, Vol. 25, No.3, March 2024

McGirt v Oklahoma and What Clinicians Should Know About Present-Day Child Abuse and Legacies of Forced Migration, Amy D. Hendrix-Dicken, et al. *AMA J. Ethics*, 2023;25(2)

This article details the historic significance of the decision and the experiences of 3 child abuse pediatricians working as part of a multidisciplinary team while jurisdictional changes were implemented following the SCOTUS ruling.

Cultural Guide for the Development of Tribal Child Welfare Products, Paulette Running Wolf, et al., Children's Bureau, Center of Native Child and Family Resilience (2023)

This federally funded guide is designed to provide guidance to organizations, teams, and individuals developing Tribal child welfare products that reflect and embrace Tribal culture and values. It highlights major questions and considerations in the following domains: respect for Tribal sovereignty; historical trauma and historical strengths; respect for Tribal values; language; leadership; Indigenous Ways of Knowing (IWOK) and cultural protocols; relationship building; cultural appropriation; cultural applicability and cultural tailoring; reciprocity; spiritual protocol; and targeted community service provider review of tools.
