**[Attorney General Bonta Joins Bipartisan Letter Supporting the Tribal Warrant Fairness Act](#)**

OAKLAND — California Attorney General Rob Bonta today joined a bipartisan coalition of 39 attorneys general [in a letter to Congress](#) supporting the Tribal Warrant Fairness Act (TWFA), which would level the public safety playing field by empowering tribes to work with the U.S. Marshals Service to combat the Missing and Murdered Indigenous People's (MMIP) crisis. Indigenous communities are disproportionately at risk of violence, murder, and going missing. To combat this unacceptable crisis, it is critical to quickly deploy law enforcement resources where they are most needed. In the letter, the attorneys general support TWFA's aim to further tackle this crisis by providing the assistance of the U.S. Marshals Service to tribal partners to protect children and increase public safety and offer suggestions on how to further strengthen TWFA.

These programs are supported with funds from the Office on Violence Against Women, U.S. Department of Justice that are administered through the Governor's Office of Emergency Services (CalOES), the U.S. Department of Health and Human Services, Court Improvement Program, and the California Department of Social Services.

### **New Mexico Could Be First State to Address Forced Sterilization of Native American Women**

Jean Whitehorse's (Diné) Native name means "Many Children," but she only has one child. This spring, she spoke at the United Nations Permanent Forum on Indigenous Issues in New York to explain why. In the 1970s, during an emergency visit to a Gallup, New Mexico, Indian Health Service facility, Whitehorse was coerced into signing consent papers for a procedure she later learned rendered her unable to have any more children.

The focus of this article is the 2022–2024 Federal Indian Boarding School Initiative undertaken the U.S. Executive Branch. The initiative shed glaring light on the past history and present effects of a centuries-old practice by which the United States took Indigenous children from their families and forced them to attend residential schools where they were compelled to submit to Westernized and Christianized notions of “civilization.”

### **Corporeal Property and the Limits of NAGPRA, Fordham Law Review, Volume 94, Issue 2, Article 6, M. Alexander Pearl, University of Oklahoma**

The Native American Graves Protection and Repatriation Act (NAGPRA), enacted in 1990, was a landmark statute designed to address one particular consequence of colonialism. At base, NAGPRA attempts to remedy the wrongful appropriation and possession of Native American human remains and cultural items by certain entities—namely, museums and government institutions—that receive federal funding. The need for NAGPRA arose from the consequences of the mythology of Native peoples created by mainstream American cultural, political, and legal thought.

This web-only report provides preliminary statistics on key items from BJS's [Annual Survey of Jails](#) and [Census of Jails](#). The jail statistics presented include the number of persons held in local jails by inmate demographics and conviction status, the number of admissions to jail, and jail incarceration rates, from 2014 to 2024. Final statistics will be published in *Jail Inmates in 2024 – Statistical Tables* (forthcoming).

### **Emergence of Contemporary Indigenous Restorative Justice in Canada, The Honourable Leonard S Tony Mandamin, Constitution Forum Constitutionnel, Volume 34, Number 2, 2025**

From time to time, I have been asked to write on Indigenous rights in Canada, which poses a challenge because there are many Indigenous Nations in Canada each with their own differing communities, cultures, and histories. This time I was asked to write about Indigenous restorative justice in Canada. I have been personally involved in and followed Indigenous justice issues for many years, both as a lawyer and as a jurist. This piece is my attempt to articulate the emergence of Indigenous restorative justice across Canada from its earliest days beginning in the 1960's to the present date. Indigenous law continues to evolve and grow.

### **2025 Implementation and Tribal Model Court Sites Project Call for Applications**

#### **National Council of Juvenile and Family Court Judges (NCJFCJ)**

The National Council of Juvenile and Family Court Judges (NCJFCJ) is pleased to invite applicants from state and tribal dependency courts to participate in the Implementation Sites Project. The NCJFCJ, with funding from the Office of Juvenile Justice and Delinquency Prevention (OJJDP), has partnered with courts across the country since 1992 to improve the way courts handle child abuse and neglect proceedings, and to improve the court experience for children and families.

The NCJFCJ is selecting new state and tribal court sites to participate in this two-year project. The selected sites will receive training, technical assistance, and support from the NCJFCJ and national experts to implement the principles and recommendations set forth in the Enhanced Resource Guidelines, the NCJFCJ's blueprint for best practices in abuse and neglect proceedings. New implementation sites will be “laboratories for change” as

they work to implement best practices in child welfare proceedings while sharing with, and learning from, nearly 30 other sites across the country. There is no direct funding available for participating courts.

### [Governor Newsom proclaims Native American Heritage Month](#)

### [Child Welfare Policy Manual Update](#)

The Administration for Children and Families published a revision to the Child Welfare Policy Manual (CWPM) section 7.4 Q&A #5. The revision is consistent with the original Q&A and provides an update consistent with title IV-B of the Act regarding allowable uses of subpart 1 child welfare funding for family reunification services (section 437(a)(7)(b) of the Act).

### [HHS Awards \\$15 Million to Fund First-Ever Standalone National Indigenous Domestic Violence Hotline](#)

The U.S. Department of Health and Human Services (HHS), through the Administration for Children and Families (ACF), today announced a projected \$15 million, five-year grant to fund a National Indigenous Domestic Violence Hotline (NIDVH). Authorized by the [Family Violence Prevention and Services Act](#) (FVPSA), the NIDVH will be operated by StrongHearts Native Helpline, which aims to help Native Americans impacted by domestic and sexual violence by bringing together safety, sovereignty and support. The investment in the first standalone NIDVH represents HHS Secretary Robert F. Kennedy Jr.’s commitment to advancing Tribal-led solutions and addressing domestic violence in Indigenous communities.

NAGPRA Repatriation grants assist museums, Indian Tribes, and NHOs to defray costs associated with the packaging, transportation, contamination removal, reburial, and/or storage of NAGPRA human remains or cultural items. Project activities may include, but are not limited to: travel, transportation, testing or decontamination, building containers for transport, ceremonial materials, or Staff time.
