IT Mod Application Data – *Updated!*

41 Courts applied

- Added Santa Clara

154 IT Mod project proposals

\$50m requested

4 Scenarios

Cyber/Information Security (Info Sec) scenarios

- Scenario 1: Cyber/Info Sec **fully fund** + Small Court + Pro Rata
- Scenario 2: Cyber/Info Sec **fully fund** + Pro Rata
- Scenario 3: Cyber/Info Sec **fund w/\$4m max** + Small Court + Pro Rata


Infrastructure scenario

- Scenario 4: Infrastructure **fund w/\$4m max** + Small Court + Pro Rata

Scenario refinements

- Removed unapproved projects
- Allowed courts to receive funding for multiple projects
- Checked and corrected for:
 - ✓ **Funding overlap** with Language Access Services and Jury grant recommendations
 - ✓ **Funding overages** by comparing awards to requested amounts
 - ✓ **Excess funding** by checking against a standard pro rata model *after* “off the top” and “small court” applied

FY25-26 Funding Models Overview

Scenario 1R: Cyber full + Small + Pro Rata	Scenario 3R: Cyber \$4.9m + Small + Pro Rata
 <p>~ \$5.9m to fund <u>all</u> cyber/info sec approved projects</p> <p>- 19 courts for a total of 24 projects</p>	<p>Fund \$4.9m in cyber/info sec approved projects (distribute equitably)</p> <p>- 19 courts for a total of 24 projects</p>
<p>Small court floor ~\$258k (4 courts)</p>	<p>Small court floor ~\$258k (4 courts)</p>
<p>Remainder distributed pro rata ~\$6.2m</p>	<p>Remainder distributed pro rata ~\$7.3m</p>

* **Small court floor:** The smallest applicant courts that did not receive set aside (off the top) funding, received funding for their highest approved project.

** **Pro rata remainder:** Distributed the remaining amount to applicant courts with approved projects via a pro rata formula.

Recommendation

Scenario 1R: Fully fund Cyber/Info Sec

- Aligns with a branchwide priority established for FY25-26 cycle
- Aligns with courts' highest funding need
- Can fully fund all approved projects requested

Requested Action

Recommend the Scenario 1R for FY 25-26
IT Modernization Grant:

- Fully funds Cyber/Info Sec \$5.9m
- Small Court floor \$258k
- Remaining pro rata \$6.2m
